How BS 7671 2008 (2015) amendment 3 impacts on Electrotechnical assessments

From January 2015, amendment 3 of BS 7671 (yellow book) will be available. During the period between January and July 2015, both sets of standards may be used in industry. From July 2015, amendment 3 will be the sole standard.

Because of this, there will be two versions of some assessments running for a period of time and the table below details which ones will be affected and how.
