

Counsel are instructed by Ingram Lochee & Exton 18 Temple Row Birmingham B2 5dS who act for Mrs Elizabeth Mary Colman under the terms of a Representation Order dated 22 April 2015.

Counsel will see from the statement of Mrs Coleman that she was arrested for shoplifting on 4 March 2015.

Mrs Coleman was accused of steeling a coat from the clothing section of her local supermarket. She states in her writen statement that she picked up the coat and was going to try it on when her 3 year old son wanted to go to the toilet. She took the coat into the ladies' toilet. After her son had been to the toilet, she removed her own coat and tried on the coat she wished to purchase. She was happy with the fitt and left the ladie's toilet with the coats over her arm placing both coats over the handels of the supermarket trolley and continued shopping

Mrs Coleman walked round the aisles of the super market placing groceries in to her trolley. Her 3 year old son during this time was misbehaving and kept trying to put goods into her troley she did not want. He also had a tantrum in the confectionery isle as she would not buy some chocolate which were not suitible for a three year old. Mrs Colemans state of mind is overwhellmed by her prescent circumstances. She is looking after her father-in-law in his home as his main carer and visits him 4 times a day. Once she has taken her two daughters to school, she visits her farther-in-law to make his breakfast, pop's in with his lunch and returns once her husband gets in from work at 5.30 pm when she takes him a meal. Mrs Coleman then returns to her father-in-law's house about 10.00 pm when she insures he is safely in bed has taken his medication and has a drink, securly locking up when she leaves.

The night before the insident one of her daughters had a nightmare and she did not get much sleep. Mrs Coleman maintains she had not ment to walk out of the supermarket with the coat over the back of the trolley but had completely forgotten it was their until the security gaurd stopped her outside the premises: Mrs Coleman's shopping bill ammounted to £120.65 which she payed and she certainly had the means to pay for a coat. Hopefully, Council can argue that the mens rea was absent in this case.
