Can I get unit certification?

1 Information for Learners

What is the purpose of the qualifications?

The purpose of these qualifications is to equip those individuals working with parents with the essential skills and knowledge required to support parents in their parenting role. It will enable individuals to support parents to improve their understanding of their own role and their children's social, emotional, intellectual and physical needs and the context of family life.

Who are these qualifications aimed at?

The qualifications are aimed at those in a supporting role, Parenting practitioners, Parent support advisors, Parent liaison workers, Family support workers and professionals such as Social Workers or Health Visitors.

These qualifications will provide essential knowledge and skills for those learners who work with parents in a paid or voluntary capacity, in a wide range of settings.

Are there any entry requirements?

There are no formal entry requirements for candidates undertaking these qualifications. As part of the assessment for this award is based on practical activities with parents, City & Guilds strongly recommends that candidates have access to parents in a formal or informal setting.

What will I gain by taking this qualification?

The qualifications will provide essential skills and knowledge for those who work with parents. Learners will develop their knowledge and understanding of the development needs of parents and children and the influences of the parent child relationship. Learners will develop skills in building relationships with parents and colleagues, providing safe and inclusive environments, providing services to parents and supporting them in their parenting role. More experienced learners will gain recognition of their current skills and knowledge.

How can I progress by taking this qualification?

The qualifications provide knowledge and practical skills related to the NOS for Work with Parents. On completion of these qualifications candidates may progress into employment in the Work with Parents sector, progress in their current role or onto further learning such as the following City & Guilds qualifications:

There are several pathways for progression. For example:

- moving upwards from a Team member/Development worker role to a Team or Project Leader and to a Policy Officer role
- being a worker at a Family Centre such as a Nursery Nurse or a Social Worker and progressing to supervising and managing the Family Centre
- graduating from attending a parenting facilitating course to running courses for parents themselves
- moving from Level 2 Award in With work with Parents to the Level 3 Award/Certificate in Work with Parents
- moving from Level 3 Award/Certificate in Work with Parents to Level 4 Award in Work with Parents

What are the credit values for this qualification?

Level 2 Award in Work with Parents is worth 12 credits

Level 3 Award in Work with Parents is worth 12 credits

Level 3 Certificate in Work with Parents is worth 30 credits

Level 4 Award in Work with Parents is worth 6 credits

Are there any tests or exams associated with this qualification?

No, the qualification is assessed by candidate portfolio of evidence. Evidence is achieved by various means such as: observation, case studies, reflective accounts, professional discussion etc.

What documentation accompanies this qualification?

There is for centres and candidates a qualification handbook, recording forms and a centre information sheet, these are available to download from **www.cityandguilds.com**

How is the qualification assessed?

The units and qualifications will be assessed by candidate portfolio of evidence. Candidates taking the optional unit 310: Preparing to Teach in the Lifelong Learning Sector – are required to take one theory and one practical assessment, plus 30 minutes of micro-teaching practice.

I am taking the original work with Parents qualification (3598) do I need to change to the 3599?

No – the Work with Parents (3598) is an approved and recognised qualification for the Work with Parents sector.

2 Information for Centres

What do the qualifications aim to do?

- Provide those individuals working with parents essential skills and knowledge required to support parents in their parenting role
- Provide 'top-up' training and continuous professional development opportunities for staff working in the sector
- Provide experienced practitioners with recognition for their experience, knowledge and skills
- To equip front line parenting staff with practical skills and knowledge to work with parents effectively

Which levels suit which learners?

Learners at **Level 2** may be parents themselves who have been through parenting courses and are now parenting mentors, or they may work as part of a team supporting a level 3 practitioner

Learners at **Level 3** may be delivering frontline services to parents/carers in Children's Centres and /or extended schools. The units can be used to accredit the skills and knowledge they have and learners may progress through the levels or onto other qualifications and training in a related field such as Family Learning, trainer/adult educator, community development work, youth and community development work, Connexions, Children's centre parenting co-ordinator etc.

Learners at **Level 4** may be managers or potential managers who are working in a managing capacity delivering parenting services. This qualification is for those practitioners that may want to move across a wide range of settings and will be able to transfer the skills and knowledge gained from the level 3 certificate across a wide range of settings that support parents effectively in their parenting role.

What entry requirements are there for candidates?

It is the responsibility of the centre to ensure that candidates have the skills necessary to achieve the qualifications whilst there are no formal prerequisites for entry, centres must be aware that candidates will require some study and general communication to skills in order to complete the assessment requirements. Some candidates may require further support in the development of these skills, but others may not be ready to take on a level 3 qualification.

How long should a candidate take to achieve this qualification?

Each unit specifies the notional learning hours. Notional learning hours take into account the amount of time it takes to complete the unit – including study time and guided learning.

Is it possible to combine the units and have less learning time overall?

Yes. It is recommended that an holistic approach is taken for the delivery and assessment of the full qualifications.

Would it be possible for Centre staff along with other teaching/assessing qualifications such as the new Preparing to Teach in the Lifelong Learning Sector (PTLLS) or the Certificate in Teaching in the Lifelong Sector (CTLLS) to deliver/assess the qualifications?

Yes. As long as staff involved in making any assessment decisions (ie: signing off the candidates' work/units within their portfolios) also have sufficient occupational knowledge and experience to do so eg they have a sound understanding of the NOS in Work with Parents and have experience of working in the sector at the same level or a level above the qualifications/units they are delivering/assessing.

Do learners have to have a work placement to undertake the qualifications? And if so for how long?

It is strongly recommended that learners are either already working in the sector in some capacity or have access to a work setting

What age range are these qualifications aimed at?

These qualifications are aimed at candidates aged 16+

How are these qualifications assessed?

The units and qualifications will be assessed by candidate portfolio of evidence. Centres should consider innovative delivery methods when teaching the qualifications such as holistic assessment (please see handbook for guidance). Each unit has been broken down into specific learning outcomes, Candidates will need to produce evidence for each learning outcome and assessment criteria.

Do assessors and verifiers need to have the A and V units to assess/verify these qualifications?

City & Guilds considers it best practice for assessors and recommends using assessors that hold the A1. However it is not a requirement.

Is there any funding available for these qualifications?

To find out about funding for these qualifications please contact your local Learning Skills Council or local authority.

I have candidates on the original Work with Parents (3598) qualifications, what should I do?

Candidates registered on the 3598 qualifications should be encouraged to continue with these qualifications. These are approved and recognised qualifications for the work with Parents Sector and are endorsed by the LLUK, the SSC that represents the Work with Parents Sector.

3 Qualification related questions

What do I need to achieve to gain a full qualification?

The following certificates will be awarded to successful candidates on completion of the required combinations of units.

Level 2 Award in Work with Parents

1 mandatory unit + 2 optional units (please see handbook for unit options) Overall credit value for the qualification: 12 credits at level 2

Level 3 Award in Work with Parents

1 mandatory unit + 1 optional or 2 optional units (dependant on credit value) - (please see handbook for unit options)

Overall credit value for the qualification: 12 credits at level 3

Level 3 Certificate in Work with Parents

5 mandatory units plus optional units worth 9 credits Overall credit value for the qualification: 30 credits 21 credits must be at level 3 and a further 9 credits can be taken at either level 2 or 3

Level 4 Award in Work with Parents

1 mandatory unit at 6 credits

Can I get unit certification?

Candidates completing one or more units, rather than the full qualifications, will receive a Certificate of Unit Credit (CUC) which will state the credit value for the unit.
