In October 2013, Matthew Hancock MP, UK Minister for Skills and Enterprise, announced the Government's plans to implement Apprenticeship reform in England in response to the Richard Review of Apprenticeships.

The Implementation Plan sets out how Apprenticeships should be developed, undertaken and assessed in the future.

'Trailblazers' projects are leading the way in implementing these new apprenticeship reforms by developing new Apprenticeship Standards and assessment approaches.

They are led by employers and involve large and small business, professional bodies and trade organisations.
