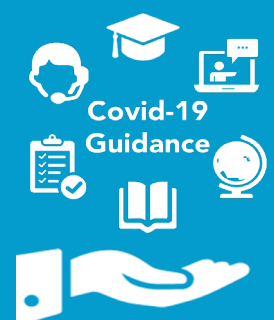

1. Introduction

Introduction

The purpose of this strategy is to provide details of the planned procedures to ensure a robust quality assurance of our Veterinary Nursing - Patient Based Assessment (VN-PBA).

The strategy is applicable to all Examiners who carry out VN-PBAs and make assessment decisions as part of this mitigated approach.

1.1 The Veterinary Nursing Patient Based Assessment

The VN-PBA is an alternative approach (mitigation) to the Objective Structured Clinical Examination (OSCE).

The VN-PBA has been designed specifically by The Royal College of Veterinary Surgeons (RCVS) as an alternative examination to the OSCE to be used during the Covid-19 pandemic by an Awarding Organisation (AO).

The sampling strategy has been devised to reflect the mitigated approach and will be reviewed, subject to duration of delivery.

The strategy will be implemented via sampling across a range of assessment decisions, global ratings and examiners.

1.2 Examiner sampling plans

The process will involve sampling assessment decisions and global ratings across all examiners to ensure a standardised approach to making assessment decisions, in line with the assessment criteria.

1.3 Internal Quality Assurer (IQA)

The IQA (previously senior examiner) must apply CAMERA when developing, implementing and maintaining sampling plans, to ensure a representative sample across;

	Factors	Need to consider
C	Candidates	Gender, age
A	Assessors (examiners)	Experience and qualifications, caseload, occupational experience, CPD
M	Methods of assessment	Professional discussions and supplementary evidence
E	Evidence	Written confirmation that the evidence is valid, authentic, current, sufficient and reliable
R	Records	Recording forms completed by examiners, correct assessment practices
A	Assessment locations	Remote virtual environment

Due to the nature of the VN-PBA, there may be some limitations but where possible, CAMERA should be applied.

1.4 Sampling of examiners

Sampling will be determined by the experience of the examiner and will be in line with risk following a RAG rated system.

As the VN-PBA is a new assessment, all examiners will be rated as high risk initially and therefore will attract a red risk rating. The IQA will sample the examiner and provide a sampling report, which will be sent to the Vet Nursing Quality team at City & Guilds. These may be shared with the External Examiner and/or the RCVS.

1.5 Standardisation activities

The purpose is to carry out activities to standardise across a range of assessment decisions to ensure all examiners make consistent, robust decisions in line with the grading criteria.

Standardisation activities will be prepared by the Vet Nursing Quality team and IQA. The activity will include any trends identified during the sampling process.

Standardisation activities will be planned for each pathway of the qualification (small animal and equine), based on risk, to reflect the number of candidates. Standardisation will always occur following the initial PBAs to ensure all examiners are standardised in their assessment decisions. Thereafter standardisation will be planned on the risk-based approach and will also consider internal and centre feedback, IQA feedback, reports and sampling.

Participation is mandatory for all PBA examiners.

Standardisation activities will be planned to take place following each series.

2. Sampling documentation

2.1 Sampling documentation

The IQA is required to carry out sampling following a risk-based approach as per the guidance in the [Examiner risk rating table](#).

Initially all allocated examiners are risk rated as high risk (red) and their assessment decisions are 100% sampled as per the strategy. Following this risk-based approach, the examiners will be amended to amber and then green, once the IQA is confident the examiner is making robust assessment decisions in line with the grading criteria.

To plan their sample, the IQA completes a sampling plan, detailing how all allocated examiners will be sampled. The IQA will complete the examiner feedback and action plan template, in line with the sampling strategy.

If an assessment decision is disagreed, feedback will be given, and the examiner asked to adjust the assessment outcome in the recording form. The IQA should provide constructive feedback on performance and highlight any trends seen in approaches to assessment made by the examiner.

Once completed, this will be distributed to the examiner who will sign and date the form and provide back to the IQA. The IQA will then send the final copy to the Vet Nursing Quality team. The IQA will also produce a sampling report for all allocated examiners at the end of each series. This report will cover the sampling activities carried out across complete PBAs during the series.

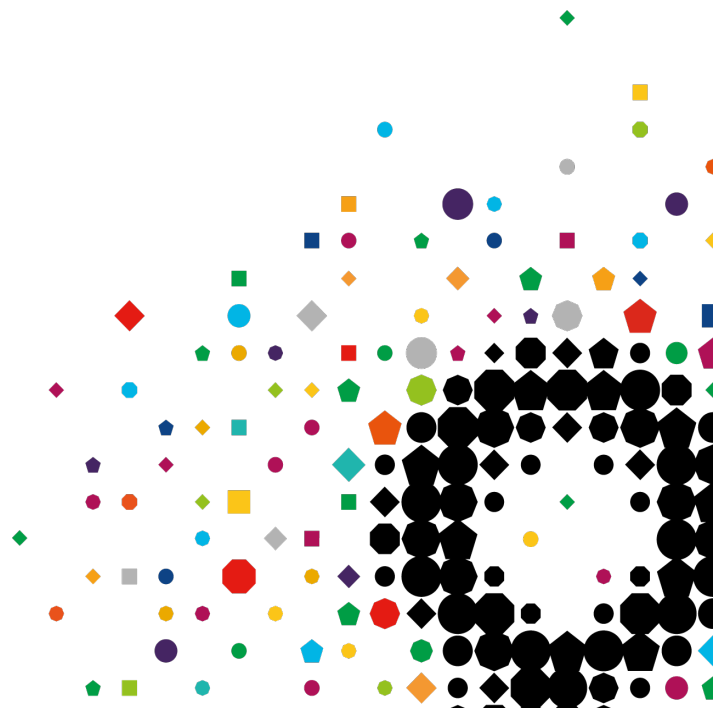
