Centres delivering Technical Qualifications with centre-assessed components will be notified of the units selected for sampling on **22 April 2025**.

The deadline for submitting grades and evidence to Moderation Portal for the centre-assessed components which have been selected for sampling is **03 June 2025**.

Centres should be aware that the deadline for the upload of grades for centre-assessed components which have not been selected for sampling is **13 June 2025**.



#### Technical Qualifications: proposed 2026 exam dates for consultation

Students should be reminded that the purpose of assessment is to reflect their own abilities at responding to and generating evidence for the tasks. All misuse constitutes malpractice which may result in malpractice sanctions for the student involved. Centres should ensure students are aware of the guidance on the use/misuse of Al.

#### What is permitted

Al may be used by a student as a source where use of the Internet is allowed for a research task or where production of evidence is allowed outside of controlled/supervised conditions. You must check the relevant assessment pack/guidance for information on what is permitted for each assessment. The student must be able to demonstrate that the work is their own. Where students use AI, they must acknowledge its use and show clearly how they have used it. How students have decided to use it could impact on the overall mark they are allocated.

#### What is not permitted

Al misuse is where a student uses an Al tool in an assessment or fails to appropriately reference it in an assessment where internet use is permitted.

Examples include the following:

- Copying sections of AI-generated content so that the work is no longer the student's own will be treated as plagiarism.
- Copying whole responses of Al-generated content will be treated as plagiarism.
- Any use of AI which means students have not independently demonstrated their own attainment is likely to be considered
- malpractice.
- Failing to reference use of AI tools when they have been used as a source of information.
- Incomplete or poor referencing of AI tools.
- Submitting work with intentionally incomplete or misleading references or bibliographies.

Al misuse constitutes malpractice as defined in the <u>JCQ Suspected Malpractice: Policies and Procedures</u>.

We encourage centres to read and reference this guidance. The malpractice sanctions available for the offences of 'making a false declaration of authenticity' and 'plagiarism' include disqualification.

## Land-Based Technical Qualifications: accessing Health & Safety test results in e-volve SecureAssess

As we approach the results day for our Technical Qualification spring series exams, we implement restrictions in our systems on the publishing of results. This is a systematic restriction which occurs for every assessment series and allows us a period for quality assurance of results. It is vital that we can continue to ensure only valid and accurate results are published.

This means that Walled Garden is not available to view results for candidates who have taken these on-demand Health & Safety tests during the period where we implement a restriction to results being published.

We understand the need to know the outcome of these tests quickly to determine whether learners should be entered to attempt the test again.

We would therefore like to ensure centres are aware that for these exams specifically, you can also access the results within the evolve SecureAssess platform. Please note, however, this is only applicable to the on-demand Health & Safety tests. You should not use this method for any other Technical Qualification exam.

Guidance to support centres with using e-volve and the SecureAssess admin console can be found on our website:



Results for completed Health & Safety onscreen tests can be viewed after the exam has finished.

Exams teams can then access the results in SecureAssess within the Results screen in the Test Administration area. Results will stay in this tab for one calendar year.

Within the Results screen, you will see rows of individual tests for individual learners. You can search for a particular learner / test and filter for the candidates for whom you wish to view their Health & Safety test results. From here, you can choose to download a results slip for each of your learners showing details of the test and overall result – however, please remember that this Results Slip is not a substitute for a certificate.
