#### NEW - City & Guilds KS4 Level 2 Technical Award - on 2024 Performance Tables

For new learners starting in **September 2022**, please ensure that you register on the new qualification to ensure that you are using the most up-to-date version, which will count in the 2024 Performance Tables.

#### Please note: new handbook is on the website

The City & Guilds qualification **number and the QN** have changed, but the titles of the qualifications remain the same. There is no content change.

There are a number of new features in the updated Technical Awards. These have been introduced to meet new design principles set out by the Department for Education (DfE) and to ensure compliance and approval for the 2024 Performance Tables.

There will no longer be a Spring exam series - instead there will be a Summer and Autumn exam series

- There will be a paper-based version of the exam only, and a synoptic assignment
- The 'Terminal assessment' rule will apply.

**For the KS4 2024 Performance table qualifications**, Ofqual introduced the requirement for a 'terminal rule' relating to the examination which specifies:

For the updated Technical Awards, due to their assessment structure, this means that both the examination and synoptic assessment must take place at the end of the programme.

Details of assessment dates will be published in the assessment and examination timetable.

To allow candidates to certificate within the KS4 year if they fail the examination on their first attempt, we have amended the grading arrangements (see Grading section in the qualification handbook); removing the requirement to pass the assessments for certification.

#### **Very important**

#### City & Guilds KS4 Level 2 Technical Awards - NEED to KNOW

- ✓ For the updated Technical Awards at KS4, both the examination and synoptic assessment must take place at the end of the programme.
- ✓ Details of assessment dates will be published in the assessment and examination timetable.
- ✓ To allow candidates to certificate within the KS4 year if they fail the examination on their first attempt, we have amended the grading arrangements (see Grading section in the qualification handbook); removing the requirement to pass the assessments for certification.

#### **Qualification approval**

- ✓ These new qualifications have new QNs and POs numbers, and meet the new rules set by DfE.
- ✓ However, as the content for assessment has not changed, the centre requirements for approvals means that if, as a centre, you already have approval for the current versions, there will be automatic approval onto the new versions.
- ✓ For all new centres, or those that have not offered the KS4 Technicals Awards previously, centre and/or qualification approval will be required following the normal process.

#### 3. Update - NEW Level 3 Advanced Beauty Therapist Standard

Our City & Guilds Level 3 Advanced Beauty Therapist Standard On-Programme solution and End-Point Assessment is on its way.

On-programme solution – we are in the process of developing a qualification for to use that will be mapped directly to this new apprenticeship standard. This qualification will support the apprentice working towards their end-point assessment.


