Beauty Professional Apprenticeship – England only – UPDATE

The Beauty Professional Assessment Plan was orginailly rejected due to a number of factors. The Beauty Trailblazer Steering group have since been working hard, along with City & Guilds, to make appropriate ammendments.

Both the Beauty Professional Standard and Assessment Plan are due to be re submitted Wednesday 25th May 2017. Following this submission we will be able to update you on the structure of the Standard, the options/routes within it and provide detail around the assessment.

City & Guilds are working hard in the background to ensure that we are ready for live launch as soon as the Steering group receive official approval.



City & Guilds Technical Awards

Introduction

City & Guilds Level 2 Technical Awards give students an opportunity to explore specific industries, experience hands-on practical learning and develop related technical skills.

City & Guilds Technical Awards have been approved by the Department for Education (DfE) to count in key stage 4 performance tables. Technical Awards are for key stage 4 students aged 14-16 (in the last 2/3 years of secondary education, in years 9, 10, 11). At 120 GLH, they are equivalent to one GCSE and can be studied over one, two or three academic years. Up to three Technical Awards count in Progress 8 and Attainment 8 performance measures as part of the "open" group of subjects.

How do I get approval to offer a Technical Award at my centre?

If your centre is already an approved City & Guilds centre, you will need to submit a qualification approval form to City & Guilds. If your centre isn't an approved City & Guilds centre, you will need to read the information on the "How to become a City & Guilds centre" to ensure you meet the criteria.

The next step is to submit a Customer Application Form and then a Centre Approval Form. There is a cost for applying for centre and qualification approval, but schools and charities are exempt from the minimum spend threshold and student numbers. Centres will have an External Quality Assurance (EQA) visit to assess the centre's suitability to offer the qualification(s) and support the centre in preparing for delivery.

Who can deliver City & Guilds Technical Awards?

Approved centres can be schools (academies, free schools, studio schools etc), University Technical Colleges (UTCs), private training providers and colleges.

How are City & Guilds Technical Awards assessed?

All City & Guilds Technical Awards are assessed through an externally set and externally marked exam and a synoptic assessment. The exam is taken on a set date and time and contributes 40% to the overall grade. There are two opportunities to take the exam in each academic year. The exam is designed to assess the student's depth and breadth of knowledge using a range of question types. The synoptic assignment is a controlled assessment, set by City & Guilds, which contributes 60% to overall grade. Students have to complete a piece of work independently which is marked by tutors and externally moderated by City & Guilds. The synoptic assignment is released to centres in the autumn term and there is a 12-week window during the spring and summer terms when students have to complete it.

How is the overall grade decided for the Technical Award?

The overall qualification grade is calculated based on the aggregation of the marks awarded for the theory exam and the synoptic assessment. These marks are converted into grades – Pass, Merit, Distinction, Distinction*. Both assessments (the exam and the synoptic assignment) must be achieved at a minimum of Pass for the qualification to be awarded.

Progression

Whilst City & Guilds Technical Awards don't limit a student's ability to progress to a range of courses at 16, they do offer students an opportunity to gain theoretical knowledge, develop an understanding of the specific industry and a number of relevant technical skills.

Funding update:

We have received an update on EFA & SFA funding which is as follows:

Briefly, there are no major changes to any of the budgets, or qualifications offered as part of those budgets, unless Qualifications have been removed due to low take up.

2017 to 2018 legal entitlements and local flexibility offer

Legal entitlements

ESFA have published the qualifications that will be available as part of the 2017 to 2018 offer for:

- English and maths legal entitlement
- level 2 and level 3 legal entitlements for 19 to 23 year olds undertaking their first full level 2 and full level 3.

In anticipation of future changes due to technical education reform and the functional skills reform, ESFA have not made any major new changes.

Qualifications already confirmed as part of the legal entitlements will continue to be available in 2017 to 2018 unless:

• They are legacy GCSES and international GCSEs in English and maths that will not be available for new starts or continuing learners from 1 August 2017.

• At level 2 and level 3 they are not part of the single offer for 16 to 23 year olds. The single offer contains GCSES, AS and A Levels, Access to HE and 2018 and 2019, 16 to 19 performance table qualifications. In addition to this, to provide stability ESFA have retained for one further year the 2017 performance table qualifications, where they are currently part of the 2016 to 2017 level 2 and level 3 legal entitlement offer.

The Hub has been updated to reflect the legal entitlements offer. Our providers should now be able to see which qualifications are available for delivery in 2017/18, unless we have not extended them on the Ofqual portal!

Local flexibility

ESFA have updated the Hub with the regulated qualifications that will be available for delivery as part of 2017 to 2018 local flexibility offer. We will confirm the 2017 to 2018 unit offer in May.

There will be no changes to the local flexibility offer or the criteria that are applied to flag the qualification as eligible for funding in 2017 to 2018. However, we should expect that there will be funding and qualification eligibility changes when local devolution and technical education reforms start to apply in 2018.

Qualifications that are currently eligible for funding will continue to be funded in 2017 to 2018, unless the qualification is no longer on Ofqual's Register of Regulated Qualifications or has been withdrawn by the awarding organisation.
