#### T Levels - Construction and building services engineering


Chosen delivery partner for T levels

We are thrilled to announce that City & Guilds has been awarded the contract by the Institute for Apprenticeships and Technical Education (IfATE) and the Department for Education (DfE) to be the delivery partner for the Construction T Level. We are delighted to have won the bid and we will be working in collaboration with EAL

We will develop new Technical Qualifications (TQs) in both On-site Construction and Building Services Engineering (BSE) which will be delivered as part of the T Level in Sept 2021.

T Levels signify a big change in technical education as they will become one of the main funded choices for students post-16, alongside A levels and apprenticeships. Equivalent to 3 A levels, the 2-year courses have been developed in collaboration with employers and businesses to ensure the content prepares learners for the world of work and meets industry needs. They will offer learners a mixture of classroom learning and industry placement.
