Qualification extensions and replacements

NVQ incremental changes

The NVQs for Wood Occupations (6571) and Trowel Occupations (6570) that were extended in November 2018 are available for funding again for 16-19s, apprenticeship and adult funding. There was some confusion over the updates in LARS for Apprenticeship funding, however, the ESFA have confirmed that they have removed the dates that had been entered, and as the last date for new starts was some time in the future, it has been left open ended. It is therefore available in Apprenticeships.

The Level 3 NVQ Diploma in Occupational Work Supervision (6576-03) that is due to expire in June 2019 has now been changed and the new QAN is 603/4147/6. The new complex number for registrations is 6576-04 and this is now available on the Walled Garden. The funding for 16-19 learners has been updated and this is already showing on LARS. Active centres have been given automatic approval to offer the new qualification 6576-04. Update on City & Guilds apprenticeship standards

City & Guilds are committed to offering the construction trailblazers and the update below gives the details on the status of each trade, the assessment plan status and a guideline of timescales for delivery.

Bricklayer 9077

We are now approved as an EPAO to offer this standard.

The assessment plan is currently undergoing amendments and we expect to hear if the updated assessment plan has been approved at the end of July. There is an assessment plan currently on the IfA website which is showing as a final assessment plan, but this will be replaced later this summer once the new assessment plan is approved. Once we receive confirmation of this we will communicate detailed timescales for when first EPA assessments will take place, which is likely to be 2020. Registrations will open for this soon, and this is planned for July 2019. For more details, please refer to the webpage:

Level 2 Carpentry and Joinery 9078

We are now approved as an EPAO to offer this standard.

The assessment plan for this standard is approved and we are currently developing all the EPA assessment material. Registrations open June 2019. EPA reservations and bookings are planned to be available November 2019. In the meantime, centres can continue with the on-programme element, which is the 6571 Level 2 NVQ Diploma in Wood Occupations (Construction), in preparation to going onto the End-point Assessment.

Advanced Carpentry and Joinery 9079

We will be applying to be approved as an EPAO for this standard soon, ready for delivery for this EPA in Autumn 2019. Detailed timescales for developing the EPA will be communicated in future newsletters, including first registrations and first assessments will be available. The assessment plan for this standard is approved although this is likely to be revised in the future.

In the meantime, centres can continue with the on-programme element, which is the 6571 Level 3 NVQ Diploma in Wood Occupations (Construction), in preparation to going onto the End-point Assessment. There are two pathways for this- Site Carpentry (6571-27) and Architectural Joinery (6571-28).

Plasterer 9086

We will be applying to be approved as an EPAO for this standard soon. Timescales will be communicated in future newsletters.

The assessment plan is currently undergoing amendments and we expect to hear if the updated assessment plan has been approved at the end of July. There is an assessment plan currently on the IfA website which is showing as a final assessment plan, but this will be replaced later this summer once the new assessment plan is approved. Once we receive confirmation of this we will communicate detailed timescales for when registrations will be open and first EPA assessments will take place, which is likely to be 2020.
