19+ Non-Levy Funding Allocations

ESFA have published new guidance on 19+ funding allocations for non-levy apprenticeship providers (those providers that deliver to non-levy employers – currently, those providers have to have an ESFA contract for this funding stream and request growth at certain points in the year).

The deadline for submitting an R04 business case was 31 March 2020. To support providers during the current exceptional circumstances due to COVID-19, ESFA understand it may have made it difficult to meet the deadline, so they will accept cases after the deadline.

Providers can submit a business case where issues with their R04 data (November 2019 data submitted in December 2019) were beyond their control and may have significantly affected carry-in allocation.

Providers contact ESFA using the online form flagged in the link to the doc below, if they need to raise a business case for increased allocation.

Skills for Wales/ Sgiliau i Gymru update



As you may be aware Qualifications Wales has laid the foundation for the future of the industry by appointing City & Guilds in partnership with EAL and WJEC to collaborate on the development of a new suite of fundable Construction and Building services Engineering qualifications in Wales. The purpose of the new developing qualifications is to help contribute towards positive outcomes for learners by making learners more work ready, empowering a bilingual nation, qualifications designed with industry and a coherent progression for learners.

We are in the midst of development and we are at the stage where both employer and provider feedback are vital for us to ensure the qualifications are fit for purpose and are ready for first teaching in September 2021. We are looking to ensure the qualifications we are developing are of the highest standard that meet employer needs by putting them at the heart of the development process.

This is where we need your help!

We are looking for employers and representatives from industry as well as college/provider staff to review elements of the draft content of the qualifications (we will give you key points to consider) and then answer some questions (probably a survey) relating to key themes we require feedback on.

Due to the Easter break we are looking to maintain momentum and continue to move forward towards the end of the month and envisage that the feedback session may take between one to two hours, with around an hour work prior to the session. This will give us the valued feedback we need from the employers/ representatives and the college/provider network to ensure development is shaped into what the industry requires.

We need support in scoping one or more of the following areas:

Construction

- Subject content (Introduction to the Built Environment, Trades in the construction and built
- environment sector, Life cycle, Employability, Maintaining H & S, Emerging technologies, 1st and 2nd trade experience in the construction &Built Environment sector)
- Working with brick, block and stone.
- Wood occupations
- Painting and Decorating
- Plastering & Interior systems
- Roofing occupations
- Construction operations and Civil engineering services
- Plant Operations

This is an opportunity for you and/or your staff to be involved to really make a difference to the qualifications that will be delivered in September 2021. Please feel free to forward to colleagues or employer associates who may be willing to get involved.

Scotland update

City and Guilds are working closely with SQA, the Scottish regulator to ensure that our processors continue to allign and support qualification delivery in Scotland as the current situation evolves. SQA is currently considering whether there are alternatives forms of assessment for the different types of qualifications they regulate. At this moment in time, they expect all Awarding bodies to adhereto the assessment strategies which have been approved by them upon accreditation. Any variation to an assessment strategy must be submitted to SQA for approval by the relevant SSO.

Project Information



The Assessor Marketing and Recruitment Project aims to address an identified industry need to support the recruitment of 100 FTE new, quality assessors to enable the efficient delivery of assessments for construction apprenticeships in Scotland. A Marketing and Recruitment Strategy will be developed and delivered in partnership with CITB, ESP and College partner.

Recruitment drive launched for new construction assessors

A project has launched to recruit and train 100 new construction assessors across all of Scotland's construction Colleges.

This is a two-year project targeting experienced tradespeople working in the construction sector. It is being driven by ESP and the Construction Industry Training Board (CITB), in partnership with 24 Scottish colleges, government agencies and private training providers. This unique project will recruit and train 100 new construction assessors that will enable the efficient delivery of assessments for apprenticeships in Scotland. This is an exciting opportunity for qualified tradespeople, who may be seeking a career change, to work in partnership with their regional college. The successful candidates will have the opportunity to help support and deliver the industry's future workforce applying their current experience to assess apprentices on site, as well as ensuring qualifications are delivered to a high standard through compliance with both internal and external awarding policies, procedures and processes.

Assessors will be recruited across a range of curriculum areas, including Carpentry & Joinery, Brickwork, Painting and Decorating, Interior Systems, Timber Frame Erection, Floorcovering, Roof Slate & Tiling, Wall & Floor Tiling, Stone Masonry, Wood Machining & Plastering.

Colleges and training providers will continue to recruit individually, while the assessor vacancies will be promoted via a national joined up campaign.

This sector leading project will also deliver a national training and development plan for new assessors which will complement essential qualifications being undertaken through the colleges.

Jim Brown, ESP Director, said: "Becoming an assessor can be a rewarding career choice and the opportunity to shape the next generation of talent. It is a key role in the success of the construction sector, helping new entrants to gain their qualifications and become highly skilled in their trade.

"Scottish Apprenticeship Week seemed like the perfect time to launch the project. The importance and value of apprenticeships are recognised throughout the country, and they would not be achievable without the help and support of the assessor role.

"This is a fantastic opportunity for experienced industry professionals to use their skills and knowledge in a new capacity and we would encourage them to find out more about this fantastic job opportunity."

Barry Dawson, Local Manager, CITB Scotland, said: "Our evidence-based approach to the funding we provide helps the construction industry to deliver tailored training and assessment to fulfil Scotland's skills needs.

"The Scottish Assessors project is a great example of how we work in partnership with training delivery organisations to ensure that construction has the right people, with the right skills, in the right place.

"The recruitment and upskilling of assessors for specific trades – and in specific regions of Scotland – will have a hugely positive impact on the delivery of a greater number of much-needed, fully trained and qualified apprentices to the Scottish workforce."

Gordon Nelson, FMB Scotland Director said: "Many of our Master Builder members take great pride in recruiting and training construction apprentices for their business.

Our members have high standards, which is why it is important that the new assessors have sufficient skills and knowledge to ensure apprenticeship qualifications are delivered to high standards too.

Some members have already expressed an interest in becoming assessors, which is very encouraging. Through engaging with our members across Scotland, the FMB will help attract the assessors needed to ensure Scotland's construction industry has a bright future."

"Future-proofing our industry and attracting the right talent who are ready to learn the skills that we need to deliver high quality new homes for our customers is a real focal point for our business.
