#### 3. Handbook updates

## 3.1 Changes made to Animal Management Qualification Handbooks:

## 0172 Animal Welfare Legislation update - England only.

We have updated our Technical Qualifications to reflect changes in legislation for **England** only. The Animal Welfare (Licensing of Activities Involving Animals) (England) Regulations 2018 has replaced:

- Performing Animals (Regulation) Act 1925
- o Pet Animals Act 1951
- Animal Boarding Establishments Act 1963
- Riding Establishments Act 1964
- Breeding of Dogs Act 1973

- Dangerous Wild Animals Act 1976
- o Zoo Licensing Act 1981
- Breeding of Dogs Act 1991
- Breeding and Sale of Dogs (Welfare) Act 1999

## Work Experience (Level 2)

### 3.2 Updated guidance on work experience in Level 2 Technicals qualification handbooks:

#### Guidance at the front of the handbook:

Work experience will provide learners with the opportunity to participate in the world of work and gain practical experience that is relevant to both the qualification and future employment possibilities. Each learner is expected to complete a 150 hours work experience placement as part of the programme. This work placement should be with an employer that will provide the learner with structured opportunities to develop the skills and knowledge that are relevant to the qualification and should be undertaken in a real business environment relevant to the subject interest of the learner. Work experience may be gained by a number of routes, e.g. as part of an industrial placement whilst within the programme, whilst working on a planned daily or weekly basis on the centre's commercial and/or educational facilities, whilst undertaking voluntary work within the industry, or as a member of a group of learners invited to carry out practical work on a suitable business. The work placement can take place at any time during the learning programme. Centres should be able to provide evidence that the work experience placement has been completed by the learner and this evidence may be reviewed on request by City & Guilds.

The 150 hours work experience is included in the Total Qualification Time

### **Guidance within the relevant unit:**

Learners must complete 150 hours work experience. Centres should be mindful of their responsibilities for ensuring that work placements have appropriate supervision, insurance and health and safety policies in place and that learners have access to appropriate support whilst on placement. This requirement is subject to external quality assurance through sampling of learner evidence, which must be provided by centres upon request by City & Guilds.

## 6. Maths & English – Functional Skills reforms

Functional Skills have changed! With effect from 1 September 2019 all learners being registered for Functional Skills must be registered for the reformed qualification. If your centre is approved to deliver the legacy Functional Skills qualification (3748) please ensure that you have applied for fast track approval to deliver the reformed Functional Skills qualifications (4748). **Details here**.

Functional Skills continues to meet the requirements of funding for both study programmes and apprenticeships. A range of developmental maths and English qualifications to support learners on their journey are also funded, please see our **funding catalogue** for more information.

#### 8. Work-based Qualifications

Whilst not part of the new apprenticeship standards in England, the Work-based Diplomas for all subject areas continue to be available. Centres may wish to use them to help shape the on-programme part of an apprenticeship, or wider competency within a working environment.

Please note however, that apprenticeship funding may not be available for them. As before, Work-based Awards, Certificates and Diplomas open for registrations continue to be able to be used as part or full time vocational delivery and may be used within study programmes where appropriate.

#### **Certificates of Competence (COCs)**

There is a range of City & Guilds NPTC certificates of competence (CoCs) which can be integrated within a study programme built on City & Guilds Level 2 & 3 Technicals qualifications. Some of these CoCs are regulatory licences to practice, but all offer your learners additional specialist skills that help them gain the skills employers' value and subsequently pursue a successful career in the land-based sector.

### 9. Update on qualification funding status and nested delivery (England only)

The DfE have recently announced their intentions with respect to some legacy qualifications that they will stop funding from 1 August 2020, and also delivery models whereby a smaller qualification is 'nested' within a larger qualification.

## Review of post-16 qualifications at Level 3 and below

Following the review of post-16 qualifications at Level 3 and below in England, the Department for Education (DfE) has confirmed its decision to withdraw funding approval from older, pre-existing qualifications where an equivalent mapped redeveloped qualification existed for inclusion in 2020 performance tables.

The City & Guilds pre-existing land-based qualifications directly impacted are in the red columns; the qualifications in the green column will still be funded:

Learners starting these City & Guilds pre-existing land-based qualifications (in the red columns) from 1 August 2020 will not be funded through:

- 16 to 19 study programmes
- Level 3 legal entitlement (funded through the AEB, irrespective of where the learner resides in England)
- Advanced learner loans (loans)
- European Social Fund (ESF)

The DfE will continue to fund learners who started studying these pre-existing qualifications **before 1 August 2020,** until they complete the qualification, or they reach the qualification's certification end date, whichever happens sooner.

### "Nested" pre-existing qualifications

The DfE have also considered the use of these pre-existing qualifications where they are 'nested' within a larger qualification suite. This means that a learner who achieves the smaller qualification can use it to count towards achieving the larger qualification in the same suite. E.g. learners undertaking a 90-credit diploma and then topping up to a 1080 Extended Diploma in the following year.

From 1 August 2020, any learner who started a smaller pre-existing qualification listed above in the 2019 to 2020 funding year will not be able to progress to a larger pre-existing qualification within the suite in 2020 to 2021, and still be funded. This is because the DfE will not approve the pre-existing qualifications for funding from 1 August 2020.

The DfE do not want to disadvantage these learners, so have put in place a transfer process for these nested pre-existing qualifications. This process is only available for the 2019 to 2020 funding year.

In the 2019 to 2020 funding year, DfE advise Centres should make both of the following points clear to their learners:

- 1. learners will not be able to progress to a larger qualification in the following year, once they have claimed a smaller qualification
- 2. learners have the option to start on a larger qualification in their first year and claim certification for a smaller qualification

E.g., If a learner starts on a 1080 Extended Diploma qualification in the first year and chooses not to progress to the second year, the provider can claim certification for that learner for a smaller qualification in the same suite, such as 360 or 540. The provider can only do this if the learner has met the rules of combination for the smaller qualification claimed and achieved it in the first year.

Centres may already have learners who have applied to start a smaller qualification in 2019 to 2020, or who have already started a smaller qualification. Centres should tell these learners that they will not be able to progress to a larger qualification in 2020 to 2021 and still be funded. Centres should give them the option to enroll on the larger qualification at the start of the 2019 to 2020 funding year.

Therefore, Centres delivering pre-existing qualifications listed above that are part of a suite of nested qualifications in the 2019 to 2020 funding year, are strongly encouraged to start the learners on the larger qualification. The learners must also agree to enroll on the larger qualification.

If a learner meets the rules of combination for a smaller qualification within the 2019 to 2020 funding year, they can choose not to progress to the second year of the larger qualification. In these cases, Centres can claim certification for the smaller qualification.

This process applies to:

- 16 to 19 study programmes
- level 3 legal entitlement (funded through the AEB, irrespective of where the learner resides in England)
- loans

Centres accessing ESF support are advised to seek specific clarification from the relevant government department.

This updated funding guidance does not impact City & Guilds Technicals qualifications (in the green columns in the table above) delivery or funding.
