# T Level Quarterly Update October 2022

# This quarter's highlights:

## **Provider Approval Process**

The approval window for eligible providers opens on Monday 27th February 2023, ready for first teaching in September 2023.

To date, we have approved 254 T Level applications for the 2022/23 academic year. Please be aware, in order for you to deliver your selected T Levels, your TQA will need to arrange a time with you to complete your Action Plan. Your TQA should have reached out to you already to begin this process.

Please make sure you set a date over the next couple of weeks to meet with them and discuss any outstanding actions.

#### Updates to the Professional Development Platform

Changes are coming to the Education and Training Foundation's (ETF) Professional Development Platform (PDP).

As part of the annual review of the training needs analysis functionality on the PDP, the ETF has identified a number of ways to make the site more user friendly, easier to navigate and better able to point users to the information they need.

To make these updates, access to the T Level Professional Development (TLPD) area of the PDP site will need to be removed for around three weeks in August 2022. During that time, users will not be able to view their existing training needs analysis results, book upcoming courses or browse T Level resources.

However, the ETF has published a number of ways to ensure that users can continue their T Level CPD throughout the summer – but they need to prepare now.
