

As we get closer to September 2022, the first teaching will commence for the T Level Technical Qualifications (TQs) in Management and Administration, Engineering and Manufacturing. We'll also have new construction centres delivering the Onsite Construction and Building Services Engineering (BSE) for the first time. Our in-delivery centres will be taking their learners into their second year. Hence, all our activities continue, and we want to make sure that we are providing you with plenty of opportunities to access all the support as part of the preparing to deliver phase.

We recently produced a new Teaching, Learning and Assessment guide, now published on our dedicated webpage, is helpful for anyone delivering the T Level TQs. ## This quarter's highlights



### **Provider Approval Process**

The approval window opened in February, for eligible providers to submit their application for the following City & Guilds T Level TQs, available for teaching commencing from September 2022:

- 8710 T Level Technical Qualification in Building Services Engineering for Construction
- 8711 T Level Technical Qualification in Onsite Construction
- 8730 T Level Technical Qualification in Engineering and Manufacturing (Core)
- 8712 T Level Technical Qualification in Maintenance, Installation and Repair for Engineering and Manufacturing
- 8713 T Level Technical Qualification in Engineering, Manufacturing, Processing and Control
- 8714 T Level Technical Qualification in Design and Development for Engineering and Manufacturing (8714)
- 8715 T Level Technical Qualification in Management and Administration

Providers are encouraged to submit their applications as soon as possible to ensure they are approved in time for the first teaching in September.

# **Tutor resources update**

Hodder Education will publish paid for textbooks to accompany the core components for the following T Levels:

- Onsite Construction due to be published May 2022
- Building Services Engineering for Construction due to be published April 2022
- Engineering and Manufacturing due to be published October 2022
- Management and Administration sample chapters will be available closer to the publication date, March 2023.

We've a wide range of free tutor resources to support Onsite and BSE centres - available on our Resources hub area. All the resources will be editable, so you can adapt them according to your individual teaching requirements.

Coming in August 2022: New tutor resources for the Engineering and Management core components, to cover:

- schemes of work to help tutors plan teaching sessions

- · worksheets various activities that tutors can use to engage learners in and out of the classroom
- multiple choice questions to check learners' understanding of what has been taught in each session.

### Building Services Engineering and Onsite Construction Employer Set Projects (ESP)

For learners taking the current live ESPs, the deadline for candidate evidence submission to City & Guilds is Friday 13 May 2022. We'll soon provide detailed guidance on how to upload the candidate evidence to Walled Garden.

Within each qualification page for Building Services Engineering (BSE) and Onsite Construction there are sample ESP documents available. It's important to note that these documents are samples only. They can be used for formative assessment but must not be used for the Summer 2022 series. They are not the live assessment for the summer series.
