##### Management and Administration & Engineering and Manufacturing

From Friday 24th June the approval window for September 2022 delivery will have closed. Approval activities will still be occurring, and providers may still be in contact with the Quality Team and their TQAs.

Please can Providers ensure all approval documents we provide are read, to check you have received approval for all the (Technical Qualifications (TQs) you applied for. Please also check the TL-A1R and/or TL-A2R to ensure you address any action points. Your TQA will be following up on these actions in preparation for starting delivery.

#### Tutor resources update

Tutor resources will be available for the core content of Management and Administration, and Engineering and Manufacturing by the end of August. 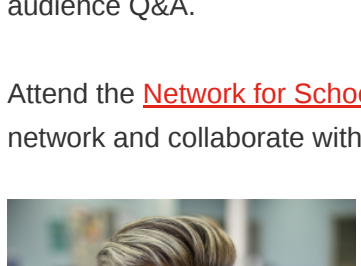
##### HE update
