This quarter's highlights



Provider approval process

The T Levels approval window opened on Monday 27 February for first teaching in September 2023. If you wish to apply for Full Provider approval, you must complete and submit a TL-A1 form. This is relevant for all eligible Providers who do not currently deliver any other T Levels with City & Guilds. If you already deliver a T Level with City & Guilds, you will need to complete and submit a TL-A2 extension approval form.



You can find the forms on the <u>T Levels Resource Hub</u>, along with the TL-DS form, which should be used in place of CVs for your staff. However, you are still able to submit CVs via the T Level Service Portal should you prefer. If you don't yet have access to the Service Portal, you will receive this shortly after you submit your application form.

Please be aware, your allocated TQA will be in regular communication with you in the 30 working days following your application being submitted, and potentially longer.

Assessment update



Summer results

We will issue summer T Levels results to Providers on Monday 14 August (instead of the usual Wednesday). This will allow more time to prepare results to be shared with learners on Thursday 17 August (they are embargoed until this date). We will be updating our key date schedules in the coming weeks.

Learner completion data spreadsheets

As part of the Ofqual VTQ results action plan, which supports the successful delivery of 2023 Level 3 VTQ results, your centre will have received a letter from Ofqual setting out the required deadlines regarding confirmation of which learners are expected to receive results this summer.

As part of this action plan, City & Guilds provided access to an online file (via secure link) listing all learners with current registrations on Technical Qualifications at your centre. We asked you to confirm, within this file, if these learners are due to achieve their qualification this year, if they are still on programme but not due to complete, or if they have been withdrawn.

We require this information to ensure we have full visibility of learner achievement and ensure results are released on time. Once complete we will contact you if we identify any discrepancies, such as any learner due to complete that does not have the required bookings.

Please note: Providers must comply with this data request to be in line with Ofqual VTQ results action plan. If you have any queries, please contact **technicals.quality@cityandquilds.com**.

Employer-Set Project (ESP)

The ESP delivery window for Building Services
Engineering, Onsite Construction and Management and
Administration opened on 3 April and will close on 12 May,
which is the final day to upload your evidence to Walled

Consultation on proposed key dates

Draft key date schedules for 2024 and 2025 have been published for consultation. We are seeking feedback from T Level Providers on the proposed key assessment dates for the 2024-2025 academic year. If you are currently delivering or will be delivering any of the following T Level technical qualifications, please review the proposed dates for the autumn and summer series and send us your feedback.

- Building Services Engineering for Construction (8710)
- Onsite Construction (8711)
- Maintenance, Installation and Repair for Engineering and Manufacturing (8712)
- Engineering, Manufacturing, Processing and Control (8713)
- Design and Development for Engineering and Manufacturing (8714)
- Management and Administration (8715)

This is an opportunity for T Level Providers to indicate any issues by completing the feedback form. Feedback must be submitted by 28 April 2023 for any changes to be considered before the final key dates schedules are published in July 2023.

JCQ Al guidance

You may have already heard of ChatGPT and other forms of artificial intelligence (AI) which could be used by your learners to complete their assessments. To offer support to centres the Joint Council for Qualifications (JCQ), of which City & Guilds is a member, has produced some **quidance**.

While the potential for learner Al misuse is new, most of the ways to prevent its misuse and mitigate the associated risks are not; and you will already have established measures in place to ensure that learners are aware of the importance of submitting their own independent work for assessment and for identifying potential malpractice. This guidance reminds centres and assessors of best practice in this area, applying it in the content of Al use.



Important points to note:

- centres should explain the importance of learners submitting their own independent work
- centres should ensure that assessors are familiar with Al tools and their risks
- learners must acknowledge use of AI when used misuse of AI tools is malpractice

Within the document, there is a list of potential indicators of AI use that may help identify work where learners have misused AI. Please do pass this information on to all your colleagues.



Government guidance update: Delivering T Levels in 2025

All providers currently funded to offer classroombased study programmes to 16- to 19-year-olds can now register to deliver T Levels from September 2025. You must **register before midnight on 22**March 2024 to be eligible to receive an up-front funding allocation to support T Level delivery in the 2025-to-2026 academic year.

Providers who register before 28 July 2023 will have access to implementation planning support and future capital funding for T Levels to support delivery in 2025.
