Dear Provider,

We hope you are keeping well during this time. Thank you for your continued input and support, it is greatly appreciated and we hope you're having a pleasant summer, even if it isn't as you had planned.

It has been another busy quarter for us here at City & Guilds and EAL. We are pleased to share that we have successfully met the Institute for Apprenticeships and Technical Education (IfATE) requirements for the second milestone. We are now working hard towards the next milestone submission and on the Technical Qualification (TQ) development as part of our T Level delivery for September 2021.

Since our last update in May, we have published the updated draft TQ specifications that were produced for milestone 2. Please note that these are subject to change, they provide a good indication of the content for On-Site Construction and BSE. TQ development continues to progress at pace and after completing the submission of materials for milestone 2 the development team are working



Following a change in the mandatory requirements of the specialisms in the BSE pathway all specialisms are under further review and revised guided learning hours are being developed in conjunction with updated content and the new requirements.

A number of validation events with employers and providers on both content and assessments have taken place throughout July. These will continue over the coming weeks as we finalise these materials to ensure the content meets industry requirements.

The development team are now also producing the Guide Standard Exemplification Materials.

These will be used to support and guide providers on the quality and standards expected, at both threshold competence and distinction grade boundaries.

Industry placements updates

There is revised guidance for the 2020 to 2021 academic year delivery of industry placements, capacity, and delivery fund. Because of the impact Covid-19 has had on delivery of industry placements and the ability of providers to build capacity in the second half of the 2019 to 2020 academic year, the industry placement delivery target has been reduced to 25% of qualifying students for the 2020 to 2021 academic year.

ESFA will also allow delivery across two academic years where students commence a two-year programme beginning in 2020 to 2021 and where a minimum of 50% of placements are successfully completed by the end of the 2020 to 2021 academic year.

All providers with a capacity and delivery fund allocation will receive a letter outlining their 2020 to 2021 academic year delivery targets and the required level 2 and level 3 split.

Gatsby Foundation update

The Gatsby Foundation is working with local areas as they build coherent planning for technical education ahead of the introduction of T Levels. We are gathering feedback from these areas to share good practice from institutions working in collaboration.

Each of the local areas – Greater Manchester, Lancashire, Liverpool City Region, Sheffield City Region, and the West Midlands – are working with their providers on several key themes:

- Data analysis using the occupational maps and labour market information to identify the priority technical education pathways and opportunities in the area
- Supporting technical education provision bringing together route curriculum networks to plan and share CPD and curriculum development
- Employer engagement facilitating shared approaches for industry placements, curriculum co-design and delivery
- co-design and delivery
 CEIAG bringing technical education routes into local CEIAG strategy.

To share some of the successes from these areas, and other providers as they prepare to deliver T Levels, we have launched a <u>new microsite area</u>.

The video resources on the site highlight a range of topics, including early preparations for T Levels, industry placement case studies from employers, student and provider perspectives, and collaborative planning and delivery of staff CPD. We hope that these examples of good practice raise some useful points to consider for others also planning technical education provision and thinking about the practical requirements for delivering T Levels. We will continue to add materials to the site, so please check back, and sign up to the Gatsby Technical Education Newsletter for more updates.

Education and Training Foundation (ETF) – T Level Professional Development

ETF is currently busy designing and developing the T Level Professional Development (TLPD) offer for the next cohort of providers, which will be available from September 2020.

The TLPD offer aims to ensure that further education and post-16 providers are T Level ready. This means ensuring that teachers, trainers, leaders and support staff have the teaching skills, subject knowledge and confidence needed to deliver high-quality courses from the outset.

The CPD will take the form of online and face-to-face modules, webinars, networks, industry placements, workshops and events. If you would like to undertake some CPD ahead of the autumn term, there are a number of teaching and training modules available on Foundation Online Learning. This includes understanding T Levels – which gives staff an insight into the implications of T Levels for their role, and will help them to advise students about T Levels and their potential benefits – as well as modules covering pedagogy, professional practice, and formative assessment, and for those in leadership roles.
