- Compile the Examiner's Report for written question papers
- Advise on queries and enquiries concerning the question paper as requested by City & Guilds
- Review candidates scripts where the candidate has appealed their result
- Participate in meetings related to the subject at the request of City & Guilds
- Attend training and regular meetings to ensure best practice is adhered to
- Undertake training as requested by City & Guilds
