What is the content of this qualification?	<p>On successful completion of the qualification learners will be awarded either the L3 Advanced Technical Extended Diploma in Health and Care (Health) or L3 Advanced Technical Extended Diploma in Health and Care (Care).</p> <p>Year 1: learners complete 9 mandatory units:</p> <ul style="list-style-type: none"> • Introduction to health and care • Personal and professional development in health and care • Equality and diversity in health and care • Effective communication in health and care settings • Safeguarding for all in health and care • Safe working in health and care • Understanding cognitive impairment • Understanding individual care needs • Quality service provision in health and care. <p>Year 2: learners complete 7 mandatory units:</p> <ul style="list-style-type: none"> • Social policy in health and care • Person centred working with children, young people, parents and carers • Provision for adults in health and care • Research in health and care • Life span developments – health and care needs • Understanding physical disabilities and exploring mental health wellbeing • Structure, organisation and function of the human body. <p>Learners can then choose a Health or a Care pathway and complete 2 further units:</p> <p>Students choosing the Health option will go onto study:</p> <ul style="list-style-type: none"> • Principles and models of healthcare • Science in health and care.

How is the qualification assessed and graded?	<p>To gain this qualification, learners must successfully achieve the following assessments:</p> <ul style="list-style-type: none"> • two externally set, internally marked and externally moderated controlled synoptic assignments • two externally set, externally marked tests, taken under examination. <p>Please note: with effect from summer 2019, learners completing Advanced Technical Extended Diploma Qualifications 1080 GLH will now show as having triple grading.</p>
