

To support preparing the candidates for employment in the nail industry, candidates are also required to compile an industry portfolio and it **must** be completed to a standard that would be credible to share with a potential employer. This portfolio should consist of images the candidate has produced including a range of nail services and techniques such as natural nail work, gel polish, enhancements and nail art techniques over the duration of their course both within the centre and externally.

The industry portfolio is a separate assessment from the synoptic assignment and should be compiled throughout the qualification.

Case studies

For completion of these units' learners must complete and provide evidence of:


Body Massage – **36** treatments and practical observations of 12 different clients

Aromatherapy – **60** treatments and practical observations of 10 different clients – minimum of 80% of treatments must be massage, the remainder can be compresses, inhalation, making up blends for other applications. **Reflexology** – **100** treatments and practical observations 15 different clients – learners should be encouraged to incorporate their anatomy & physiology into their practice.

This must include; consultation records, with detailed treatment plans, and records. Learners must also complete reflective practice throughout their learning through a reflective log or journal.




