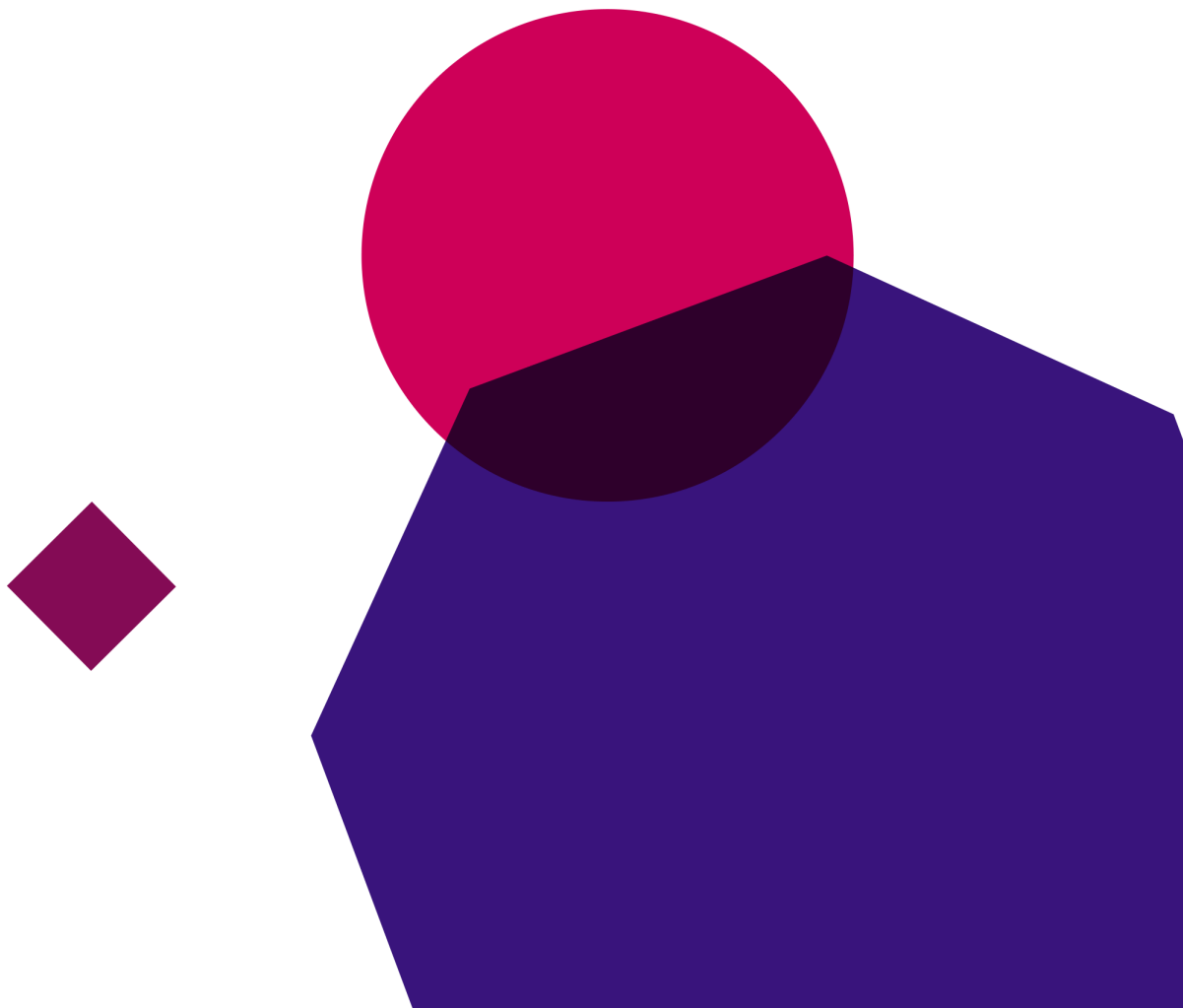
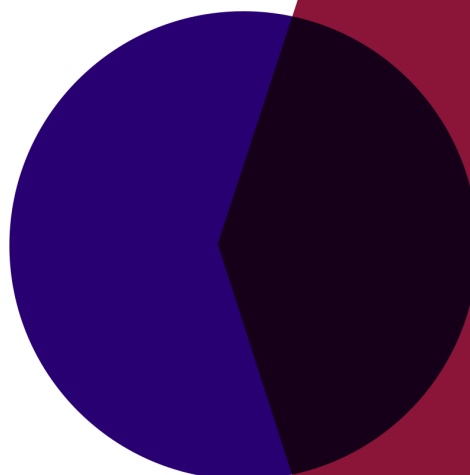

Introduction

As part of City & Guilds response to the disruption caused by the Covid-19 pandemic, we are offering an Autumn assessment window for our Technical Qualifications and this includes exams, synoptic assessments and other centre assessed components (see Annex 1).

The Autumn series is only available for students who were due to sit assessments in summer 2020 and either:

- received a Centre Assessment Grade (CAG) result and were not satisfied with the outcome; or
- did not receive a CAG result due to there being insufficient evidence

It is not an additional assessment series for students enrolled for spring / summer 2021 assessments.

Autumn Assessment window

Where students complete the Autumn assessment series but already have a result from a previously achieved assessment or CAG result, the best result will contribute towards the overall qualification grade.

Where students received CAG results for summer 2020, these do not count as an attempt for the Technical Qualifications. Please remember, however that if students have previously exhausted their attempts prior to summer 2020 (i.e. two attempts in total for Level 2 Technical Awards or Technical Certificates or three attempts in total for Level 3 Technical Level Qualification), they are **not** eligible for the Autumn assessment series.

The deadline for booking eligible students onto the autumn exam series is **11 September**. Please note **we will only be providing paper-based exams** for the autumn series. The exam timetable document will be published on the resource and support page [here](#).

Synoptic assignments and other centre assessed components: Autumn 2020

Centres must book eligible students via Walled Garden, by **11 September**.

Students will complete the 2019/20 synoptic assessments and/or other centre assessed components; where they have completed some or all parts of the assignment prior to lockdown, this work can be used. Any outstanding components must be completed before the submission deadline. The 2020/21 synoptic assessments and/or other centre assessed components must not be used.

Please note that any outstanding practical components must be completed in line with published government guidance on social distancing. If centres have any questions about the logistics of undertaking practical assessments, please contact us for further advice.

Centres must submit marks/grades for all students sitting in the autumn assessment window, along with evidence for a sample of students (for the synoptic assignments) using the Moderation Portal by **6 November**. Please refer to our published *Marking and Moderation Guide for Centres* for submission requirements.

Below are examples of the different scenarios which eligible students could fall under:

1. Students have completed all components of the synoptic assessment prior to 20 March 2020 and the centre has marked them.

Action: Centre to book students for the assessment, upload marks and evidence to the Moderation Portal

There is no requirement to complete the assessment again.

2. Students have completed all components of the synoptic assessment, prior to 20 March 2020 and the centre has not marked them

Action: Centre must mark all students work that they wish to submit, book students for assessment and upload marks and evidence to the Moderation Portal

There is no requirement to complete the assessment again.

3. Students have completed some components of the synoptic assessment prior to 20 March 2020 and the Centre has not completed marking

*Action: Students must complete outstanding components and the centre must complete marking within revised assessment window. Tasks **should only be** repeated if it is necessary for the outstanding assessment e.g. a planning task. The Centre needs to book candidates for the assessment and upload the marks and evidence to the Moderation Portal*

4. Students have not completed any components of the synoptic assessment

Action: Students will need to complete all components of synoptic assessment and be marked by the centre within the revised assessment window. The Centre needs to book candidates for the assessment and upload marks and evidence to the Moderation Portal

Please note that moderation visits will not take place for the autumn series. In some instances, however, some form of remote activity may be required. In these instances, we will contact centres to discuss the requirements and practicalities of this.

Centres should have been provided with login details for the Moderation Portal for the summer 2020 series, however if you are unable to locate these please contact us. Centre marking will be subject to moderation as in previous series.
