


# A quick recap

- Reformed Functional Skills qualifications available for first teaching from September 2019.
- Based on new Subject Content, and subject to new Regulatory Conditions.
- Distinct purposes for Entry level vs levels 1 and 2
  - Entry level sound grasp of the underpinning skills and basics
  - Levels 1-2 apply these skills effectively to a range of purposes in the workplace and in other real life situations.



- More explicit assessment of 'underpinning' skills not just incidentally through problem-solving tasks
  - no spelling/grammar checkers or dictionaries allowed within English Writing
  - word lists at Entry level
  - assessment at all levels with and without a calculator for maths.
- · Awarding organisations currently seeking approval from Ofqual to offer new qualifications.

#### Development timelines



- 31 August 2019 last registration for current (3748-01 and 3748-02) qualifications
- September 2019 revised FS English and FS Mathematics qualifications available for first teaching
- 31 August 2020 last certification for current (3748-01 and 3748-02) qualifications.

# Stage 2 – it's good to share...

Staff directly involved in the <b>teaching</b> of Functional Skills familiar with changes and likely implications for their practice?			
Staff directly involved in the <b>assessment</b> and <b>internal quality assurance</b> ( <b>IQA</b> ) of Functional Skills familiar with changes and likely implications for their practice?			
Staff involved in the <b>administration</b> of Functional Skills (eg exams staff) aware of changes, and possible implications for their role?			
Staff responsible for the teaching/assessment of <b>other subjects</b> delivered alongside Functional Skills have a good understanding of the reforms and possible implications for their practice?			
<b>Senior leaders</b> have a good understanding of the Functional Skills reforms, especially any resourcing and/or programme planning implications?			
Staff involved in the delivery of <b>GCSE</b> English and Mathematics understand the changes to Functional Skills, and how this might affect the relationship between Functional Skills and GCSE.			

#### Stages 3 and 4

**Operational processes** 

Implications of Functional Skills reform for initial and diagnostic assessment process (including tools used for this)

Qualification Approval arrangements for reformed Functional Skills qualifications (including obtaining Direct Claims Status).

Implications of any changes to assessment duration understood.

Implications of non-calculator section of FS Mathematics assessment.

Implications for spell/grammar checkers and dictionaries no longer being permitted within FS English Writing.

Changes to format of FS English Speaking, Listening and Communication (SLC) assessments.

Any operational implications for Entry level assessments – eg word lists within FS English.



#### **Planning and implementation**

Accessing key documents to support the reformed Functional Skills qualifications (once available) from City & Guilds

Implications for **Apprenticeships**, eg programme hours, ensuring qualifications achieved/attempted as necessary prior to Gateway.

Implications for **Study Programmes**, eg programme hours, condition of funding rules, meaningful progression.

Briefings and CPD support in place for staff, to ensure all understand changes and implications for their practice.


Building on existing good practice – eg experience of embedded/contextualised teaching of maths and English.

Changes relationship between Functional Skills and GCSE understood – appropriate decisions taken regarding use of each.

Relationship between Functional Skills and 'bite-sized' maths and English qualifications (eg City & Guilds' Mathematics/English Skills (3847) suite) understood – appropriate decisions taken regarding use of each.
