

# Legacy Functional Skills – 3748-01 and 3748-02

#### Last external assessment opportunities have now passed!


Deadline	Action
18 June 2021	Final date for candidates to attempt Entry level FS English (Reading/Writing) or FS Mathematics assessments.
	Final date for candidates to be assessed for FS English (SLC) (all levels).
30 June 2021	All <b>IQA/EQA activity</b> relating to any internally marked/assessed components of legacy FS English or FS Mathematics must be complete.
	Any ' <b>prior achievement with another awarding organisation</b> ' claims for individual components of FS English must be submitted (eg 3748-701 for Reading at Entry 1).
2 July 2021	All Level 1-2 external assessment results (for FS English Reading/Writing and FS Mathematics) issued.
16 July 2021	All results entry claims for internally marked/assessed components of legacy FS English or FS Mathematics must be submitted.
	All results entry claims for FS English certification modules (ie 3748-901, -902, -903, -904, -905) must be submitted.
31 July 2021	All certificates for legacy FS English (3748-01) and FS Mathematics (3748-02) issued.



## FS ICT (3748-03) is <u>not</u> affected by this, and is continuing!





# FS Reform (nearly...) two years on

# Functional Skills reform.

#### Context for 2019 reforms

- Government accepting need for an 'alternative' alongside GCSE.
- Perceived need for more
  - 'rigour'
  - consistency between awarding organisations
  - focus on underpinning skills (as well as problem solving)
  - alignment with school-age national curriculum..

#### What changed?

- New subject content (published by DfE in February 2018).
- Explicit assessment of 'underpinning skills'
  - eg at least 25% of marks within FS Maths
  - prescribed word list for FS English
  - non-calculator section
  - dictionaries and spell checkers no longer allowed during assessment of writing.

Subject content functional skills: mathematics

- New assessment conduct requirements
  - ICE document for L1-2 exam components
  - clearer rules about who can/can't invigilate
  - tighter security protocols.


