(2391) Certificate in Inspection, Testing and Certification of Electrical Installations

We have taken the decision to extend the current suite of 2391 (10 & 20) qualification until 31st July 2012. This is to ensure the replacements qualifications and assessments meet

the highest standards. Subsequent exam dates post July 2012 for 2391 will be published soon.

There will be assessor guidance around the practical Rigs for centres by the end of December, this will give centres enough time to make preparations for any alterations to existing Rigs or new Rigs.
