Unit aim

This is the ability to make the best use of e-mail software to safely and securely send, receive and store messages. On completion of this unit a candidate should be able to understand and use a range of basic e-mail software tools to send, receive and store messages for straightforward or routine activities.

E-mail tools and techniques will be defined as 'basic' because:

- the software tools and functions will be predetermined or commonly used; and
- the techniques used will be familiar or commonly undertaken.

Learning outcomes

There are **two** learning outcomes to this unit.

The learner will:

- 1 Use e-mail software tools and techniques to compose and send messages
- 2 Manage incoming email effectively

Guided learning hours

It is recommended that **15** hours should be allocated for this unit. This may be on a full-time or part-time basis.

Details of the relationship between the unit and relevant national occupational standards

This unit is linked to the Level 1 IT User NOS devised by e-Skills UK.

Support of the unit by a sector or other appropriate body

- Use appropriate language, respect confidentiality
- Use copy lists with discrimination

Address book:

- Add, edit, delete contact entries, contacts list

Outcome 2 Manage incoming email effectively

The learner should be able to and understand:

Guidelines and procedures:

- Set by employer or organisation, security, copyright
- Netiquette
- Password protection

E-mail responses:

- Decide on priorities, gather information needed to respond, decide when and who to copy in, what to do about attachments

Organise and store e-mail:

- Folders, subfolders, delete unwanted messages, backup, address lists

Email problems:

- Due to message size or number of attachments, messages from unknown users (SPAM, junk, chain-mails, 'phishing'), viruses

This is the ability to use a software application designed for the creation, editing and production of largely text-based documents.

On completion of this unit a candidate should be able to use a range of basic word processing software tools and techniques to produce appropriate, straightforward or routine documents. Any aspect that is unfamiliar will require support and advice from others.

Word processing tools and techniques will be described as 'basic' because:

- the software tools and functions will be predetermined or commonly used; and
- the techniques needed for text entry, manipulation and outputting will be straightforward or routine.

Learning outcomes

There are **three** learning outcomes to this unit.

The learner will:

- 1 Enter, edit and combine text and other information accurately within word processing documents
- 2 Structure information within word processing documents
- 3 Use word processing software tools to format and present documents

Guided learning hours

It is recommended that 20 hours should be allocated for this unit, although patterns of delivery are likely to vary.

Details of the relationship between the unit and relevant national occupational standards

This unit is linked to the Level 1 IT User NOS devised by e-Skills UK.

Support of the unit by a sector or other appropriate body

This unit was developed by e-Skills UK.

Assessment

- 1.7 Store and retrieve document files effectively, in line with local guidelines and conventions where available

- 2.1 Create and modify tables to organise tabular or numeric information
- 2.2 Select and apply heading styles to text

Outcome 3: Use word processing software tools to format and present documents**Assessment Criteria**

- 3.1 Identify what formatting to use to enhance presentation of the document
- 3.2 Select and use appropriate techniques to format characters and paragraphs
- 3.3 Select and use appropriate page layout to present and print documents
- 3.4 Check documents meet needs, using IT tools and making corrections as necessary

The following guidance is not a prescriptive list of activities; they are suggested areas that a learner could show competence in to achieve this unit. Centres may use some or all these activities or some of their own devising to teach and help learners complete this unit successfully.

Types of information:

- Text, numbers, images, other graphic elements (eg lines, borders)

Keyboard or other input method:

- Keyboard skills: using the full range of keys, typing accurately and efficiently, keyboard shortcuts

Other input methods: voice recognition, touch screen, stylus

Editing tools:

- Editing tools appropriate to the type of information, for example:
 - select, copy, cut, paste, undo, redo, drag and drop, find, replace, insert, delete, size, crop, position

Store and retrieve:

- Files (eg create, name, open, save, save as, print, close, find)

Outcome 2 Structure information within word processing documents

Tables:

- Add table, insert and delete rows and columns, adjust column width

Unit 115 Bespoke software

Level: 1
Credit value: 2
NDAQ number: A/502/4395

Unit aim

This is the ability to select and use a suitable bespoke software application to carry out an appropriate data processing task. It includes understanding the capabilities of the software and the types of tasks for which it is suitable, as well as the skills and techniques needed to use the software application appropriately and effectively. On completion of this unit a candidate should be able to use basic bespoke software tools and techniques appropriately for straightforward or routine information. Any aspect that is unfamiliar will require support and advice from others.

Bespoke software tools and techniques will be defined as 'basic' because:

- the software tools and functions involved will be predefined or commonly used;
- the range of inputting, manipulation and outputting techniques are straightforward or routine; and
- the data type and structure will be predetermined or familiar.

Learning outcomes

There are **two** learning outcomes to this unit.

The learner will:

- 1 Input, organise and combine information using bespoke software
- 2 Use tools and techniques to edit, process, format and present information

Guided learning hours

It is recommended that 15 hours should be allocated for this unit, although patterns of delivery are likely to vary.

Support of the unit by a sector or other appropriate body

- 2.2 Check information meets needs, using IT tools and making corrections as appropriate
- 2.3 Use appropriate presentation methods and accepted layouts

Teaching guidance

Types of bespoke information:

- Information will vary according to the software for example:
 - text, numbers, photos, scanned images, graphic elements, digital recorded sound, graphs, charts, tables

Inputting information:

- Inputting tools and techniques will vary according to the technology being used for example:
 - interface devices (eg keyboard, mouse, stylus, touch screen)
 - microphone (eg headset, built-in)
 - camera (eg web cam, video camera, mobile phone camera)

Combining information techniques:

- Insert, size, position, wrap, order, group

Guidelines for the storage and use of data:

- Set by employer or organisation or centre
- Policies relating to security, backup and data protection
- Guidelines for data format; compliance, audit and reporting requirements
- File management will vary according to the application

Outcome 2 Use tools and techniques to edit, process, format and present information

The learner should be able to and understand:

Editing, analysis and formatting techniques:

- Techniques will vary according to the software and task, for example:
 - **Editing:** select, insert, delete, cut, copy, paste, drag and drop, find, replace, page layout, labelling, alignment, orientation, colour, resolution, size, pitch
 - **Process:** sort, pre-set queries, simple operator formulas, charts and graphs
 - **Formatting:** characters, lines, paragraphs, pages, file type

Check bespoke information:

- Checks will vary according to the type of information and software, but could include:
 - spell check, grammar check
 - accuracy of figures
 - labelling and size of images
 - volume of sound

Presentation methods:

- Methods will vary according to the software and task, for example:
 - on screen display, publishing on a web site, hard copy print out, digital file
- Organisational house style, branding

Unit 116

Data management software

Level: 1

Credit value: 2

Unit aim

This is the ability to use a software application designed to store and retrieve data needed for a variety of business functions. It also includes an understanding of the features and facilities of the software and the purpose for which the data is stored.

On completion of this unit a candidate should be able to use basic data management software tools and techniques to:

- enter straightforward or routine information using pre-set data-entry screens;
- retrieve information by running predefined methods; and
- produce reports using predefined menus or short cuts.

The tools and techniques will be described as 'basic' because:

- the tools and functions will be predefined or commonly used; and
- the techniques for inputting, manipulation and outputting data will be straightforward or routine.

The structure and functionality of the data management system will be predefined.

Examples of context: Adding or amending customer details into a company CRM system such as Integra; booking patient appointments for doctor, dentist or hospital; registering new student details onto a school or college SIMS database

Learning outcomes

There are **two** learning outcomes to this unit.

The learner will:

- 1 Enter, edit and maintain data records in a data management system
- 2 Retrieve and display data records to meet requirements

Guided learning hours

It is recommended that 15 hours should be allocated for this unit, although patterns of delivery are likely to vary.

Details of the relationship between the unit and relevant national occupational standards

This unit is linked to the Level 1 IT User NOS devised by e-Skills UK.

Support of the unit by a sector or other appropriate body

This unit was developed by e-Skills UK.

- 2.2 Identify which report to run to output the required information
- 2.3 Select and view specified reports to output information to meet given requirements

The following guidance is not a prescriptive list of activities; they are suggested areas that a learner could show competence in to achieve this unit. Centres may use some or all these activities or some of their own devising to teach and help learners complete this unit successfully.

Outcome 1 Enter, edit and maintain data records in a data management system

- Use of data entry form, create new record, add record to table

Amend data records:

- Find, search and replace
- Edit record, sort, use wildcards

Check data records:

This is the ability to use a software application designed to organise and store structured information and generate reports.

On completion of this unit a candidate should be able to use basic database software tools and techniques to:

- enter straightforward or routine information into a database;
- set up a single table in a flat file database;
- retrieve information by running routine queries; and
- produce reports using predefined menus or short cuts.

The structure and functionality of the database will be predefined. Any aspects that are unfamiliar will require support and advice from others.

Database tools and techniques will be described as 'basic' because:

- the tools and functions will be predefined or commonly used; and
- the techniques for inputting, manipulation and outputting will be straightforward or routine.

Examples of context: Enter names and addresses into a customer database; update stock control data.

Learning outcomes

There are **two** learning outcomes to this unit.

The learner will:

- 1 Enter, edit and organise structured information in a database
- 2 Use database software tools to extract information and produce reports

Guided learning hours

It is recommended that 20 hours should be allocated for this unit, although patterns of delivery are likely to vary.

- 2.4 Generate and print pre-defined database reports

As a result of reviewing their work, they will be able to identify and use automated methods or alternative ways of working to improve productivity.

Unit aim

This unit is about the ability to safely set up the components of an IT system (eg personal computer - PC, keyboard, mouse and printer), removable storage media (eg data stick or external DVD drive), communication service to access the Internet and associated software and check that they are working properly. On completion of this unit the candidate should be able to select and connect up an IT system with a range of hardware, removable storage media and a communication service safely and run more advanced tests to check it is working successfully.

Examples of context: Re-assemble personal computer after moving house/office; transferring personal files to a new PC; setting up and testing a home wireless network

- 1 Select and connect up a personal computer safely with associated hardware and storage media to meet needs
- 2 Select and connect an IT system to a communication service to meet needs

Spreadsheet software

Level: 2

Credit value: 4

NDAQ number: F/502/4625

Unit aim

This is the ability to use a software application designed to record data in rows and columns, perform calculations with numerical data and present information using charts and graphs.

On completion of this unit a candidate should be able to select and use a wide range of intermediate spreadsheet software tools and techniques to produce, present and check spreadsheets that are at times non-routine or unfamiliar.

Spreadsheet software tools and techniques will be defined as 'intermediate' because:

- the range of data entry, manipulation and outputting techniques will be at times non-routine or unfamiliar;
- the tools, formulas and functions needed to analyse and interpret the data requires knowledge and understanding (for example, mathematical, logical, statistical or financial); and
- the user will take some responsibility for setting up or developing the structure and functionality of the spreadsheet.

Examples of context: Typical examples may include - monthly expenditure and sales figures, budgets, cash flow forecasts and graphs of results.

Learning outcomes

There are **three** learning outcomes to this unit.

The learner will:

- 1 Use a spreadsheet to enter, edit and organise numerical and other data
- 2 Select and use appropriate formulas and data analysis tools to meet requirements

Using collaborative technologies

Level: 2

Credit value: 4

NDAQ number: F/502/4379

Unit aim

This is the ability to use IT tools and devices for collaborative working and communications, such as web or video conferencing, instant messaging/chat, online phone and video calls; online forums, social networking sites, wikis and other centralised depositories for documents, blogging, RSS and data feeds, bulk SMS or online work management tools.

On completion of this unit a candidate should be able to facilitate the use of appropriate combinations of IT tool and devices for groups to work collaboratively by:

- planning and selecting the IT tools and devices to be used for work purposes and tasks;
- preparing and setting up access to collaborative technologies;

Any aspect that is unfamiliar may require support and advice from others.

Unit aim

This is the ability to use a software application designed for planning, designing and building websites.

On completion of this unit a candidate should be able to select and use a wide range of intermediate website software tools and techniques to produce multiple-page websites.

Website software tools and techniques will be defined as 'intermediate' because:

- the software tools and functions involved will at times be non-routine or unfamiliar;
- the choice and use of development techniques will need to take account of a number of factors or elements; and
- the user will take some responsibility for planning the website, creating or altering the template, inputting, manipulating, linking and uploading the content.

Examples of context: Create a multiple page website with menu-driven navigation for a sports club. Set up family site with photographs and linked pages for each family member.

Web page styles:

- Styles will vary according to the different elements of the website design, but may include:
 - typeface (eg font, colour, size and alignment of headings, captions or body text)
 - lines (eg type, thickness and colour of borders, tables, diagrams)

Access issues:

- The difficulties different users may have in accessing websites, accessibility guidelines, affect of download speeds (eg from different browser software, connection type, size of web page contents)

File types:

- Text (eg rtf, doc, pdf)

Word processing software

Level: 2

Credit value: 4

Unit aim

This is the ability to use a software application designed for the creation, editing and production of largely text-based documents. On completion of this unit a candidate should be able to select and use a range of intermediate word processing software tools and techniques to produce documents that are at times non-routine or unfamiliar. Any aspect that is unfamiliar may require support and advice from others.

Word processing tools and techniques will be described as 'intermediate' because:

- the software tools and functions will be at times non-routine or unfamiliar;
- the choice of techniques will need to take account of a number of factors or elements; and
- the user will take some responsibility for the inputting, manipulating and outputting of the information.

Examples of context: Typical documents may include – business letters and invoices with automated content (eg AutoText, mail merge), more complex reports and content for web pages.

Learning outcomes

There are **three** learning outcomes to this unit.

The learner will:

- 1 Enter and combine text and other information accurately within word processing documents
- 2 Create and modify layout and structures for word processing documents
- 3 Use word processing software tools to format and present documents effectively to meet requirements

Use customer service as a competitive tool

Level: 3

Credit value: 8

Unit aim

Customer service contributes to an organisation's competitive position. Customers of many organisations have choice about the services or products they use and who supplies them. Often the technical features and cost of the service or product are almost identical. If this is the case, the quality of the customer service offered makes all the difference about which supplier the customer chooses. This unit is about how the learner can play their part in ensuring that their organisation makes the best possible use of the competitive advantage that can be gained from offering superior customer service. It covers how the learner can use customer service as a tool to compete effectively with other providers of similar services and product. The unit is not for a learner whose organisation does not compete actively with others.

Learning outcomes

There are **three** learning outcomes to this unit.

The learner will:

- 1 Organise customer service to gain a competitive advantage
- 2 Deliver a competitive service
- 3 Understand how to use customer service as a competitive tool

However good the service provided, some of their customers will experience problems and the learner will spot and solve other problems before their customers even know about them. Remember that some customers judge the quality of their customer service by the way that the learner solves customer service problems. The learner can impress customers and build customer loyalty by sorting out those problems efficiently and effectively. Sometimes a customer service problem presents an opportunity to impress a customer in a way that would not have been possible if everything had gone smoothly.

Unit aim

This is the ability to use a software application designed to store and retrieve data needed for a variety of business functions. It also includes an understanding of the features and facilities of the software and the purpose for which the data is stored.

An advanced user can select and use advanced data management software tools and techniques efficiently to:

- enter complex information;
- retrieve information using complex selection criteria;
- produce customised reports from the system; and
- set up menus or short cuts.

The data management system tools, functions and techniques will be described as ‘advanced’ because:

- the software tools and functions involved will be complex and at times involve having the idea that there may be a tool or function to do something (eg improve efficiency or create an effect), exploring technical support, self-teaching and applying; and
- the input, manipulation and output techniques involved will be complex, which will involve research, identification and application.

Examples of context: Working with the software manufacturer or IT professional to develop and implement new data handling techniques; Examples of customisation includes: additional product training; creation of process triggers and workflow; assistance writing reports; complex data extracts; or implementing Business Intelligence.

Unit aim

This is the ability to use a software application designed to organise and store structured information and generate reports.

On completion of this unit a candidate should be able to select and use advanced database software tools and techniques efficiently to:

- enter complex information into databases;
- retrieve information by creating queries using multiple selection criteria; and
- produce reports by setting up menus or short cuts.

They will also be able to design, create and interrogate multiple-table relational databases.

Database tools, functions and techniques will be described as ‘advanced’ because:

- the software tools and functions involved will be complex and at times require new learning, which will involve having the idea that there may be a tool or function to do something (eg improve efficiency or create an effect), exploring technical support, self-teaching and applying; and
- the input, manipulation and output techniques involved will be complex, which will involve research, identification and application.

Examples of context: Typical ‘more complex’ reports from multiple-table relational databases may be about – customers’ buying methods, order frequency and payment patterns.

Improving productivity using IT

Unit aim

This is the ability to plan, evaluate and improve procedures involving the use of IT tools and systems to improve the productivity and efficiency of tasks and activities. They will be able to devise solutions to use IT tools to improve productivity, as well as take considerable responsibility and autonomy being prepared to offer support and advice to others.

Unit aim

This is the ability to protect hardware, software malfunction and unauthorised access. - the inputting, manipulating and outputting techniques will be complex, and will involve research, identification and application; and
- the user will take full responsibility for inputting, structuring, editing and presenting the information.

Examples of context: An interactive or multi-media presentation.

The learner will:

- 1 Input and combine text and other information within presentation slides
- 2 Use presentation software tools to structure, edit and format presentations
- 3 Prepare interactive slideshow for presentation

Guided learning hours

Set up an IT system

Unit aim

This unit is about the ability to safely set up the components of an IT system (eg personal computer - PC, keyboard, mouse and printer), removable storage media (eg data stick or external DVD drive), communication service to access the Internet and associated software and check that they are working properly. On completion of this unit the candidate should be able to select and connect up an IT system with a range of hardware, removable storage media and a communication service safely and successfully and is able to help others to do so.

Examples of context: Re-configuring a PC after a new hard disk has been installed.

Unit aim

This is the ability to use a software application designed to record data in rows and columns, perform calculations with numerical data and present information using charts and graphs.

Spreadsheet software tools and techniques will be defined as 'advanced' because:

Unit aim

- the software tools and functions used will be complex and at times involve having the idea that there may be a tool or function to do something (eg improve efficiency or create an effect), exploring technical support, self-teaching and applying;

Website access issues:

- The difficulties different users may have in accessing websites
- Accessibility guidelines, ways to increase accessibility
- Affect of download speeds (eg from different browser software, connection type, size of web page contents), ways to improve download speeds
- Ways to improve search engine results

Web page templates:

- Web page content and layout will vary according to the template, but may include:
 - text (eg body text, headings, captions)
 - images (eg still photographs, diagrams)
 - numbers (eg tables, charts or graphs)
 - background (eg colours, gradients, patterns, textures)
 - structure (eg frames, side bars)
 - moving images (eg animation, video clips)

- sound (eg clips linked to navigation, background music, video sound track)

- downloads (eg pdf files, podcasts)

Web page styles:

- Styles will vary according to the different elements of the website design, but may include:
 - typeface (eg font, colour, size and alignment of headings, captions or body text)

 - structure (eg size of frames, number of tabs, format of menu)
 - cascading style sheets

File types:

- Text (eg rtf, doc, pdf), images (eg jpeg, tiff, psd), charts and graphs (eg xls), sound (eg wav, MP3)

Store and retrieve:

- Files (eg create, name, open, save, save as, print, close, find, share)
- Version control; import/export
- File size; folders (eg create, name)

Outcome 2 Select and use website software tools and features to develop multiple page websites with multimedia and interactive features

The learner should be able to and understand:

Combine information:

- Combine images with sound (eg dub or overlay sound track onto film sequence; integrate a audio or video sequence with another application):
 - Techniques: copy and paste, insert, screen grabs/shots
 - File download (eg connect USB lead, drag and drop), file transfer protocol (FTP)
 - Forms of information: moving images, sound; pre-recorded, live, web-streaming

Editing techniques:

- Editing techniques will vary in line with the type of information, for example:
 - select, copy, cut, paste, undo, redo, drag and drop, find, replace, size, crop, position, change templates

Programming and development techniques:

- Creating links to bookmark text within a page, linking web pages together, adding a link to another website
- Altering simple code using programming language, creating code using an appropriate programming language
- Adding multimedia content to web pages
- Setting up a secure area, message board or e-mail link
- Adding meta tags

File formats:

- Change format of documents to RTF or HTML

Check web pages:

- Using help: Will vary depending on the content but may include, for example:
 - Text: spell check; grammar check, type face and size, hyphenation
 - Layout: page layout, margins, line and page breaks, tables, sections

- Images: size, alignment and orientation, suitability of file format, appropriate choice of colour mode and use of filters, fitness for purpose of image resolution

Outcome 3 Publish and test multiple page websites with multimedia and interactive features

The learner should be able to and understand:

Testing methods:

- Methods will vary but may include:
 - viewing web pages using browser software
 - testing navigation round pages within multiple page website
 - testing external links
 - testing multi-media and interactive elements

Quality problems with websites:

- Problems may vary, but could include:
 - content that is not appropriate for the template or missing
 - text that is not readable or missing
 - images that are oriented or sized wrongly
 - navigation that does not work as planned
 - multimedia features (eg sound levels, image resolution, synchronisation of sound and images)
 - interactive features (eg response to posting a message or when key fields on forms are not completed, downloads not active)

Upload and publish website:

- Upload content to a template
- Use file exchange programme to upload and publish (eg FTP or HTTP)

Unit aim

This is the ability to use a software application designed for the creation, editing and production of largely text-based documents. On completion of this unit a candidate should be able to select and use a range of advanced word processing software tools and techniques to produce complex and non-routine documents.

Word processing tools and techniques will be described as 'advanced' because:

- the software tools and functions will be complex and at times require new learning, which will involve having the idea that there may be a tool or function to do something (eg improve efficiency or create an effect), exploring technical support, self-teaching and applying;
- the techniques required will be complex, and the process of selecting appropriate techniques may involve research, identification and application; and
- the user will take full responsibility for the inputting, manipulating and outputting of the information.

Examples of context: Typical documents will require problem solving and creative thinking and may include – complex reports and content for publications such as web pages, journals, newsletters or other printed materials.

Learning outcomes

There are **three** learning outcomes to this unit.

The learner will:

- 1 Enter and combine text and other information accurately within word processing documents
- 2 Create and modify appropriate layouts, structures and styles for word processing documents
- 3 Use word processing software tools and techniques to format and present documents effectively to meet requirements
