What changes have we made?

- All units have been re-written to reflect the change in style of unit writing but also to ensure content is up-to-date.
- All assignments have been revised but more importantly you now have the ability to contextualise the practical tasks within each assignment to suit the needs of different industry sectors or local demand. Design specifications within a task can be contextualised, however, the grading criteria and the mark sheet provided in each assignment **must** be used and cannot be changed, to ensure validity and comparability of the grades achieved by candidates.
- If you would like to contextualise a task within an assignment you should complete the equivalent Word document of the assignment found on City & Guilds 7689 webpage and forward this to your External Quality Assurer (EQA) for review and approval.
- GOLA tests have been replaced by short answer questions.
- Certificate size qualifications developed to support Adult funding.
- Upfront fees – no entry fees, GOLA fees or certification fees.
- Automatic approval given to Centres already approved to offer 7579
