· What does this qualification cover?

This qualification covers a very wide range of areas related to the skills and knowledge required for working in the Saddlery industry, or progressing to further learning and training.

Depending upon which pathway is taken learners must take all of the following mandatory units:

## Saddle:

Managing Health and Safety and Employment Rights and Responsibilities within the Apparel, Footwear or Leather Industry Develop Patterns for bespoke saddle Manufacture Understand the Principles and Practices of Manufacturing Bespoke saddles Managing Quality Standards within Saddle Production

• Who could take this qualification? OR who is this qualification designed for?

This qualification is part of the Apprenticeship in Fashion and Textiles (saddlery route) or it may be taken as a stand alone qualification.

It is a work-related, competence-based qualification, and is designed for someone in work or who wishes to progress into work. It reflects the skills and knowledge needed to do a job effectively, and shows that you are competent in the area of work the qualification represents.

The qualification may allow you to combine working for a saddlery business or tack shop, and typically involves you attending one day a week at College or with a Training Provider.

There are no specific prior achievements required to take this qualification, but a Level 2 or another Level 3 qualification in Land-based related subjects could be an advantage.

You need to be 16 years old or over to take this qualification.

## WHAT COULD THIS QUALIFICATION LEAD TO?

This qualification could lead to jobs such as:

- Apprentice saddler
- Qualified saddler
- Trainee saddle fitter
- Retail Saddlery assistant
- Saddlery and Leathergoods manufacturer.
