

### Level 4 Land-based NVQs

#### **About the Qualification**

Traditionally, land-based businesses have viewed the majority of employment opportunities at level 2. However, in order to respond to future requirements over the next five to ten years, it is necessary to ensure that people are trained at levels 3 & 4. There is now an increasing need for people with managerial skills to support diversification and to enable employers to deal with the increasing use of contractors, part time, migrant workers and the legislative demands on the business.

The Level 4 NVQs are based on Lantra SSCs National Occupational Standards that were developed in December 2005. They are suitable for candidates who wish to progress into and within employment at a management level, therefore addressing future skills gaps.

There are five NPTC Land-based NVQs available at level 4

- Level 4 NVQ in Agricultural Management (0133)
- Level 4 NVQ in Amenity Horticulture Management (0329)
- Level 4 NVQ in Animal Care and Management (0256)
- Level 4 NVQ in Equine Management (7482)
- Level 4 NVQ in Floristry Business Management (6822)

## Do these qualifications form part of a recognised framework?

The qualifications are accredited by the Qualifications and Curriculum Authority (QCA) at level 4 and are therefore eligible for public funding.

  - Zoos and Wildlife Parks
  - Animal Handlers on Audio Visual Production Sets
- Level 4 NVQ in Equine Management (7482)
  - Equine Business Management
  - Business/Yard Manager
  - Elite Groom
  - Coach/Instructor
  - Horse Racing
  - Breeding
