- How and when to submit the draft standard for informal feedback and for formal approval.

- Development of an assessment plan and preparation for delivery.
- Criteria for approval of apprenticeship assessment plans.
- Allocation of funding caps to apprenticeship standards.
- Working with education and training organisations delivery.


