- Operate safely at work, minimising risks and complying with emergency procedures
- Participate in activities to develop effective working relationships
- Arrange and prepare the workplace for the maintenance of plant and equipment
- Perform maintenance procedures on mechanical plant and equipment
- Assess and deal with defects and variations in mechanical plant and equipment
- Identify and analyse the causes of defects in mechanical plant and equipment

**plus two of the following units:**

- Arrange equipment in preparation for mechanical engineering activities
- Prepare materials for the maintenance of mechanical plant and equipment
- Modify mechanical plant and equipment to meet operational requirements
- Remove components from mechanical plant and equipment
- Replace components in mechanical plant and equipment
- Establish the viability of repairing components from mechanical plant and equipment

- Understand and analyse detailed mechanical information from technical sources
- Obtain information from mechanical engineering drawings and specifications
- Analyse and recommend improvements to maintenance procedures for mechanical plant and equipment

- Monitor the performance and state of mechanical plant and equipment
- Assess the performance and state of mechanical plant and equipment
- Examine mechanical plant and equipment.

## 6. Officially recognised ways of acquiring the certificate

- Ongoing assessments carried out by the centre including observation, expert witness testimony, reflective accounts, case studies, knowledge testing/professional discussion, projects, assignments and work products
- Knowledge based assessments.

All assessment practice is quality assured by City & Guilds verifiers.

The vocational education and training is a combination of work based and/or realistic working environment based activities. Learners are required to build a portfolio of naturally occurring evidence in real working environments. As part of the assessment for this qualification is based on experience in the workplace, candidates must have access to an appropriate setting.

The recommended Guided Learning Hours (GLHs) for this qualification are 270 hours.

**Entry requirements**

City & Guilds exercises a policy of open access and does not set formal entry requirements for its qualifications. Centres are however required to ensure that learners are registered for a programme of study and examination at the appropriate level.
