### The current 1980-02/92 Level 2 Certificate in Principles of Providing Security Services (QAN: 600/3270/4) is being replaced on 1<sup>st</sup> January 2015

During the summer the Security Industry Authority (SIA) and SIA-endorsed Awarding Organisations undertook a review of the existing licence-linked units, which exist within the Level 2 Certificate in Principles of Providing Security Services, to ensure they continued to reflect best and current industry practice.

Based on this review all 5 below listed SIA licence-linked units have been re-written therefore the current 1980-02/92 will close for new registrations on the 31/12/2014 and will be replaced with 1980-03/93 Level 2 Certificate In Principles of Providing Security Services (QAN: 601/4834/2) from 01/01/2015.

Existing SIA licence-linked units last result submission permitted (no exceptions will be allowed): **31/03/2015**

## How will this affect existing learners on 1980-02/92 Level 2 Certificate in Principles of Providing Security Services (QAN: 600/3270/4)

All existing learners will still be able to certificate on the full qualification 1980-02/92, Level 2 Certificate in Principles of Providing Security Services, up until 31/12/2016.

<u>But</u> all learners will only be able to claim results on the below 5 SIA licence-linked units up until to **31/03/2015**. City & Guilds <u>will not allow or accept</u> any late results submissions for the below units after this date.

- Level 2 Conflict Management for the Private Security Industry | K/600/6310
- Level 2 Working as a Door Supervisor | K/600/6307
- Level 2 Working as a Security Officer | L/600/6705

Any learners who have not passed these units on or before 31/03/2015 will need to re-register on the new 1980-03/93 and retake all new replacement units for the above listed units as learners' prior achievements for these units will not be transferred (all other unit achievements within this qualification will be carried over).

### Gaining approval for the new 1980-03/93 Level 2 Certificate in Principles of Providing Security Services (QAN: 601/4834/2)

Due to changes in some of the units all centres will be required to gain full approval for the new 1980-03/93 Level 2 Certificate In Principles of Providing Security Services (QAN: 601/4834/2) in January 2015 once the qualification is live.

There will be no fast track or automatic approval available for this qualification.

#### Changes to the apprenticeship framework.

All apprentices registering on or after the 1<sup>st</sup> January 2015 should be registered on the new **198003/93** Level 2 Certificate In Principles of Providing Security Services (QAN: 601/4834/2).

#### **Recognition of Prior Learning**

Due to the SIA review of the existing below licence-linked units any learners who have gained the below units will not be exempt from the 5 new replacement units within the new 1980-03/93.

Centres can use recognition for prior learning towards the training with all learners being required to undertake any additional training needed to cover new learning outcomes and assessment criteria.



Once completed the learner will also be required to take the end assessment for each of these units even if the learner has achieved the old versions of these units before.

#### **Proxy Units**

Proxy/ exemption units will be available in the new 1980-03/93 but **can only** be used to claim the below units, if a learner has achieved these prior to taking up the qualification. These proxy units cannot be claimed for the old units which close for certification on 31/03/2015 or any other listed UAN units which are similar.
