

Scheme approval for 4101SVQ in Automotive Maintenance & Repair, Body & Paint, Vehicle Fitting & Roadside Assistance Levels 1, 2 and 3

Centres currently offering the City & Guilds **Automotive 4004 to 4007 Awards** and wishing to offer the **4101 NVQ** should refer to the table attached which indicates the awards the centre must be approved for to enable Fast Track Approval. Centres not approved for the appropriate schemes should obtain approval for **4101 NVQ** by completing a scheme approval form (SAP) and submitting to your national/regional office. An External Verifier visit may be necessary.

Fast track approval is achieved by completing the attached fast track approval form and scheme approval will be an automatic process. Fast Track Approval is appropriate providing:

- You have been granted approval or have been actively offering the component qualifications within the last two years
- There are no unresolved actions from your external verifier visits.
- There have been no changes to centre information previously supplied. **This means that no changes should have been made to any of the following centre details:**
 - Assessors & internal verifiers
 - Satellite centres
 - Staff resources
 - Physical resources

However, where minimal changes to the 4 items above have occurred, centres may still use the fast-track form, but must complete and attach Form APU contained in the document **Providing City & Guilds Qualifications – edition four**. In such cases, an additional verification visit **may** be necessary to confirm that the approval criteria continue to be met and this may incur a cost of £150. **In submitting the attached fast-track form without an APU, centres are confirming that there are no changes to the above. Failure to inform City & Guilds of changes may result in approval being withdrawn.**

Fast track approval is on condition that the centre is adequately resourced for the qualifications requested. This will be confirmed by the external verifier at the first verification activity following approval.

As a City & Guilds Centre you are encouraged to maintain a Centre Quality Assurance Manual and to have a detailed written Quality Assurance system. Examples of both have been provided as part of your Fast Track application.

During your first External Verification visit following Fast Track Approval your External Verifier will examine and discuss your Centre's Quality Assurance systems and procedures.
