What makes up an Apprenticeship?

Apprenticeships combine vocational learning with practical, on-the-job experience and training. They enable apprentices to develop their skills through industry-recognised qualifications, whilst getting paid. Most Apprenticeship programmes take between 18 and 24 months depending on the industry sector and ability of the apprentice.

Automotive Apprenticeships consist of the following main elements:

- VCQ or competency-based component (what used to be called NVQ).
- Knowledge-based or Technical Certificate component (VRQ).
- Either Key Skills or Functional Skills.
- Employee Rights and Responsibilities (ERR).
- Personal Learning and Thinking Skills.

What levels are the Automotive Apprenticeship Frameworks available at?

The Intermediate Apprenticeship is level 2 and the Advanced Apprenticeship is level 3.

I want to deliver Automotive Apprenticeships. How do I register the candidates?

The best way is to register them under one of the automotive packages (9420) as this registration will give you access to all the qualifications which are part of that apprenticeship framework and would also be more economical than making a registration for each of the qualifications individually.

How do we deliver and assess Employee Rights and Responsibilities (ERR)?

All Apprentices will receive an induction to the workplace and to the Apprenticeship programme. ERR will be covered through a separate qualification: City & Guilds Level 2 Award in Knowledge of Employee Rights and Responsibilities for the Automotive Sector (4277)
Qualification Reference Number: 600/1216/X

This qualification is also included in the Apprenticeship package (9420). Centres approved to run any of the automotive qualifications part of the framework (that is, 4270, 4271, 4290 and/or 4291) would have been given automatic approval.

What are PLTS?

Personal, learning and thinking skills (PLTS) provide a framework for describing the qualities and skills needed for success in learning and life. The PLTS framework has been developed and refined over a number of years in consultation with employers, parents, schools, students and the wider public.

The framework comprises six groups of skills:

- independent enquirers
- creative thinkers
- reflective learners
- team workers
- self-managers
- effective participants.

I have completed my level 2 apprenticeship in framework 4. Can I register directly into the level 3 advanced apprenticeship framework 1?

Yes, if you have achieved your level 2 apprenticeship in framework 4 you can register directly into the level 3 advanced apprenticeship framework 1. You don't need to take any additional units at level 2 prior registration to the level 3 in framework 1.

You just register directly into the level 3 advanced apprenticeship framework 1 and then you will need to achieve all components of the framework, that is: the level 3 VCQ, the level 3 VRQ, the transferable skills, ERR and PLTS.

Please see previous question about equivalence between frameworks as you may be able to use some evidence from level 2 for the generic units.

How do I claim results for transferable units or prior learning?

To claim transferable results, you submit them through the Walled Garden. In the case of online tests, you need to submit the results with a Pass by using the proxy components through the Walled Garden (they are called 'credit transfer for...' and the title of the unit), not the online test number.
